state park. Most park activities focus around the 40-acre late. The park has 50 camp sites and 13 modern cabins.

#### Public Access to Waterways

Tools for enhancement: Chesapeake Bay Watershed Agreement

The strategy for protecting and restoring the Chesapeake Bay Watershed established a watershed-wide public access goal to "increase public access to the Bay and its tributaries by adding 300 new public access sites by 2025."

Governor's Treasure-A-Day Initiative: 1,460 treasures, 4 years

A treasure is any of the following:

- A permanent land protection project (acquisition or conservation easement) that protects natural, cultural or historic assets
- A recreational asset such as a new park, trail, water access site, garden, arboretum, playground
- A designation action such as a new state or national historic register, scenic river or byway, recreational use agreement, new or restored habitat for wildlife watching/viewing all of which must be publicly accessible

Natural Tunnel State Park

Mr. Conkle presented the proposed Master Plan Update for Natural Tunnel State Park.

From the Executive Summary:

This Natural Tunnel State Park Master Plan Executive Summary is an update to the official unabridged master plan document adopted on May 16, 2000, by Department of Conservation and Recreation (DCR) Director David G. Brickley. The master plan was amended on June 10, 2009, by DCR Director Joseph H. Maroon. The original master plan for Natural Tunnel State Park was written in 1971 by Hayes, Seay, Mattern and Mattern Architects and Engineers, Roanoke, Virginia. This master plan update is intended to set forth a clear vision for the future (based on the phased development). This 2014 executive summary represents the most recent five-year review described in §10.1-200.1 of the *Code of Virginia*. It outlines the desired future condition for Natural Tunnel State Park when it is fully developed.

Natural Tunnel State Park is located in Scott County on State Route 871, Natural Tunnel Parkway, approximately one-mile northeast of Route 23. The Park is 13 miles north of Gate City and twenty miles north of Kingsport, Tennessee, five miles from Duffield and twenty miles south of Big Stone Gap, Virginia. The park is located in the Clinchport and Dufflield quadrangles of Scott County, Virginia.

Bear Creek Lake State Park

Mr. Conkle presented the Executive Summary for Bear Creek Lake State Park.

This Bear Creek Lake State Park Master Plan Executive Summary is an update to the official unabridged master plan document adopted on December 6, 2002, then amended on April 28, 2009, by DCR Director Joseph H. Maroon. This master plan update is intended to set forth a clear vision for the future (based on the phased development). This 2014 executive summary represents the most recent five-year review described in §10.1-200.1 of the *Code of Virginia*. It outlines the desired future condition for Bear Creek Lake State Park when it is fully developed.

Bear Creek Lake State Park consists of some 328.7 acres nestled in the heart of the 16,242-acre Cumberland State Forest in central Virginia's Cumberland County. The park is located 4.5 miles northwest of the Town of Cumberland. Access is from U.S. Route 60.

The property today known as Bear Creek Lake State Park was originally acquired from private citizens around 1932 by the United States Department of Agriculture under the Federal Resettlement Administration. In 1939 the State Forest Service took over management of the property. In 1940 it was opened as a "State Recreation Area" with concession, bathhouse facilities, and boat rental. In 1962 the property became a state park. Providing recreational opportunities to the public was a major consideration behind the establishment of Bear Creek Lake State Park in the earliest days, and this continues to be a focus of efforts today.

#### **State Parks Update**

Mr. Seaver gave the report for the Division of State Parks.

Mr. Seaver addressed the following State Park initiatives.

- Partnership for Parks
- Virginia Correctional Enterprise
- DMV "Drive for Parks" Partnership
- Fee Adjustments "Virginia Resident Discounts"
- Natural Play Areas Grant with NPRA
- Best Practices Working Group

Mr. Seaver said that Mr. Elton would discuss the Partnership for Parks initiative.

Mr. Seaver said that State Parks is working with Virginia Correctional Enterprises to work on a number of areas including the linen provision for state park cabins. Other possible

collaborations include building campsite amenities such as grills and doing preliminary work on cabin construction for items that can be transported to the parks and installed. He said it is a partnership that is being revisited by this Administration and that there are quality products that can be used in the parks.

Mr. Seaver said another project is with the Department of Motor Vehicles. Other states such as Montana, Michigan and Kansas offer a similar program that allows drivers to register their vehicle and purchase a State Parks' pass at the same time. The potential proceeds would be used for maintenance and other programs. This option would be available online beginning in May, 2015.

Mr. Apicella suggested that this be initiated with the private sector including outdoor sporting goods stores. Mr. Seaver said that the current approach was a phased approach.

Mr. Elton noted that as part of the Partnership in Parks the Virginia Parks Association and Virginia Garden Club are pursuing the idea of a State Park license plate.

Mr. Seaver said that there was a concern that the license plate might dilute the choice for the passes.

Mr. Seaver said that with regard to fee adjustments DCR would be offering "Virginia Resident Discounts." There will be about a 15% differential for out of state vs. in state rentals. There will also be a pilot project for an out of state parking fee. Staff will be monitoring that closely.

Ms. Jackson asked about the percentage of out of state visitors.

Mr. Elton said that about 40% of overnight visitors are out of state, but that there were no clear numbers regarding day use by out of state visitors.

Mr. Seaver said that DCR has applied for three grants for Natural Play Areas through the National Parks and Recreation Association. A Natural Play Area is not the traditional playground. It is a discovery area that takes natural materials to develop play areas for children. If received the grant will allow the construction of about three more areas.

Mr. Seaver said that the Best Practices continue to work. A new group is called the Diversity Project. This group will address diversity to determine what parks can do to better serve those populations that may have different cultural backgrounds. The group will also look at recruiting for park employees.

Mr. Elton said that the Partnership with Parks was a project of the Virginia Parks and Recreation Association and the Virginia Garden Club. He noted that Mr. Wingo is a member of the steering committee for the Partnership with Parks.

The campaign is the centennial project of the Garden Club of Virginia. The will celebrate their centennial in 2020. They are committed to raising \$5 million in five years. The project is

designed to renovate and create new technology based exhibits for park visitor centers. The focus will be to help explain stewardship of Virginia's natural resources. All parks will have a component of this.

Mr. Elton said that the 6-year campaign, endorsed by Governor Terry McAuliffe and the First Lady Dorothy McAuliffe, will result in a total of 13 state park visitor centers with new, innovative and engaging exhibits that will interpret our state's cultural and natural history for all ages while promoting a healthy active outdoor lifestyle for our citizens.

- Illegal trash dumping and drug use on North Landing River (filled industrial dumpster)
- Illegal artifact hunting at Savage Neck Dunes
- Off-road truck damage to rare wetland habitat at Cherry Orchard Bog
- Landowner complaints at Ogden Cave (nearest operations staff three hours away)
- Spray paint graffiti at Crow's Nest, Buffalo Mountain

Mr. Smith said that limited staff and resources continue to be a hindrance to providing the high quality of service Virginians expect from DCR's Virginia Natural Heritage Program.

resolution in support of the rebenchmarking for the Virginia Natural

Heritage Program.

#### **State Parks Project Fund**

Ms. Altholz gave an update regarding the audit. She said that there had been several concerns that her Division was addressing these and developing appropriate policies.

Ms. Altholz noted that the Conflict of Interest training and filing by staff and board members was one of the 93 audit points. She said that staff from DCR Human Resources would be contacting Board members to assist in the filing process.

The next audit will be in April, 2015.

Ms. Partee reviewed the State Parks Project Fund. She noted that this fund was not an audit point, but it was noted that the project requests should be coming to the Board for approval. Previously this had been done, but the process had ceased in recent years.

Ms. Partee cited § 10.1-202 of the *Code of Virginia* dealing with "Gifts, funds, and fees designated for state parks; establishment of funds."

Ms. Partee noted that this fund had previously not been on the state accounting system but was being transferred accordingly. The fund is at the control of the Director, but expended with the advice of the Board. She said that DCR wished to begin the process of bringing project requests back to the Board.

Ms. Partee noted that the list of current projects was provided in member packets.

Mr. Elton noted that this fund was a remnant of an earlier program, the Virginia State Parks Foundation. Initially the Foundation was established because the General Assembly believed there needed to be a vehicle to allow parks to accept contributions. There were challenges with managing the funds and with receiving corporate donations.

At a regular meeting of the Virginia Board of Conservation and Recreation held on Tuesday, December 16, 2014 at Bear Creek Lake State Park in Cumberland, Virginia, the following resolution was unanimously adopted.
