Executive Director's Report

Ms. Brown and Mr. Casway discussed HB 1441, a Confidential Consent Agreement that became effective July 1, 2003. Ms. Brown explained that this Agreement was for minor infractions that do not harm the public. No public record will be available on a Confidential Consent Agreement.

Discipline Committee

Ms. Ekleberry reported that the Board currently has 21 complaints in Investigations; five (5) cases at Board level; and one (1) case has been returned to Enforcement for additional information.

Ms. Brown reviewed a Consent Order signed by Marcha Ortiz, L.C.S.W., whereby her license was indefinitely suspended. Following discussion Mr. Weston moved to approve the Consent Order. Mr. Offerman seconded the motion. The motion carried.

Mr. Foster discussed the changes proposed at the meeting on May 9, 2003 regarding 18 VAC 140-20-150 Professional Conduct.

Ms. Brown reported that a draft of the Newsletter is ready and has been forwarded to Ms. Keast. It is expected that the Newsletter will be mailed prior to the September 10th Board meeting.

Mr. Offerman reported on his contacts with other Board offices regarding the requirements for continuing education. Following discussion it was determined that the issue would be on the Agenda for full discussion at the September 19, 2003 meeting.

Lynch sent a letter to Ms. Ekleberry, Chair, requesting that the Board consider regulatory changes that would allow Bachelor of Social Work students to sit for the License Social Work Examination in their final semester of school. The Chair requested a copy of the letter be sent to the Board for discussion at the September 19th meeting.
