The Chair recognized Ms. Dubner and Mr. Stallings and invited their comments regarding the allegations.

Mr. Weston moved that the Informal Conference Committee certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the Closed Meeting was convened. The motion was seconded and carried.
