CONFERENCE

SCHEDULED: HELEN L. FLYNN, LCSW

Ms. Flynn appeared before the Informal Conference Committee on Friday, April 23, 2004 at 9:15 a.m. to review allegations that she may have violated portions of the laws and regulations governing the practice of social work in the Commonwealth of Virginia.

The Chair recognized Ms. Flynn and Mr. Plofchan and invited their comments regarding the allegations. Both made opening statements.

Mr. Weston moved that the Committee convene a closed meeting pursuant to Section 2.2-3711(A)(28) of the *Code of Virginia* for the purpose of deliberation to reach a decision in the matter of Ms. Flynn regarding the allegations outlined in the Notice of Hearing. Additionally, Mr. Weston moved that Ms. Brown and Ms. Larimer attend the closed meeting because their presence in the closed

meeting is deemed necessary, and their presence will aid the Committee in its deliberations.

The motion was seconded and carried.

The Committee reconvened in open session.

Mr. Weston moved that the Informal Conference Committee certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom on Information Act and only such public business matters as were identified in the motion by which the Closed Meeting was convened. The motion was seconded and carried.

ACTION:

The Committee concluded that Helen Flynn violated 18 VAC 140-20-150(1) and (9) and 18 VAC 140-20-160(3) and (5) governing the practice of social work in Virginia and imposed a monetary penalty of \$2,000 on Ms. Flynn and placed her license on probation for not less than two (2) years.
