of her probation be GRANTED and that she be issued an unrestricted license to

practice as a licensed clinical social worker in the Commonwealth of Virginia.

The Board expects Ms. Bryant to maintain a course of conduct in her capacity as

a licensed clinical social worker commensurate with the requirements of Title

54.1, Chapter 37, of the Code of Virginia (1950), as amended, and the Board of

Social Work Regulations.

Pursuant to Section 2.2-4023 of the Code, the signed original of this Order

shall remain in the custody of the Department of Health Professions as a public

record and shall be made available for public release, inspection and copying

upon request.
