Mr. Sinclair moved to approve the amended agenda. Mr. Smith seconded the motion which was unanimously approved by members: Bennett, Roseboro, Sinclair, Smith, and Terry.

Ms. Terry moved to approve the July 17, 2018 Board meeting minutes. Mr. Smith seconded the motion which was unanimously approved by members: Bennett, Roseboro, Sinclair, Smith, and Terry.

Public Comment Period

File Review

Regarding File Number 2017-02665, Marshall Enterprises Auction and Realty LLC, the Board members reviewed the Consent Order as seen and agreed to by Marshall Enterprises Auction and Realty LLC. Mr. Smith moved to accept the Consent Order which cites the following violations of the Board's regulations: 18VAC25-21-150.G (Count 1), 18VAC25-21-150.J (Count 2), and 18VAC25-21-150.C (Count 3). For these violations, Marshall Enterprises Auction and Realty LLC agrees to

pay the following monetary penalties: \$100 for the violation contained in Count 1; \$150 for the violation contained in Count 2; \$500 for the violation contained in Count 3; and \$150 in board costs, for a total monetary penalty of \$900. In addition for the violations of Counts 1, 2, and 3, Marshall Enterprises Auction and Realty LLC agrees to surrender its license. Mr. Sinclair seconded the motion which was unanimously approved by members: Bennett, Roseboro, Sinclair, and Smith. As the presiding Board member, Ms. Terry was not present for the discussion or vote.

Regarding File Number 2018-01892, Quinn's - Central Virginia LLC, the Board members reviewed the Consent Order as seen and agreed to by Ouinn's - Central Virginia LLC. Ms. Roseboro moved to accept the Consent Order which cites the following violations of the Board's regulations: 18VAC25-21-110.A.1.a (Count 1), 18VAC25-21-110.A.2 (Count 2), and 18VAC25-21-110.A.4 (Count 3), 18VAC25-21-110.A.7 (Count 4), 18VAC25-21-110.A.8 (Count 5), and 18VAC25-21-180.4 (Count 6). For these violations, Quinn's - Central Virginia LLC agrees to pay the following monetary penalties: \$200 for the violation contained in Count 1; \$200 for the violation contained in Count 2; \$150 for the violation contained in Count 3; \$100 for the violation contained in Count 4; \$100 for the violation contained in Count 5; \$750 for the violation contained in Count 6; and \$150 in board costs, for a total monetary penalty of \$1650. In addition for the violations of Counts 1, 2, 3, 4, and 5 Quinn's - Central Virginia LLC agrees to provide a copy of its current contract within thirty days of the effective date of the Consent Order. The contract must be in compliance with Board Regulation 18VAC25-21-110. If Quinn's - Central Virginia LLC fails to comply with this condition, then its license will be suspended until compliance is obtained. Mr. Smith seconded the motion which was unanimously approved by members: Bennett, Roseboro, Sinclair, and Smith. As the presiding Board member, Ms. Terry was not present for the discussion or vote.

Regarding File Number 2018-01696, More Than Moving for Seniors Inc, t/a Susan's Selections, the Board members reviewed the Consent Order as seen and agreed to by More Than Moving for Seniors Inc, t/a Susan's Selections. Mr. Smith moved to accept the Consent Order which cites the following violations of the Board's regulations: 18VAC25-21-180.4 (Count 1) and 18VAC25-21-180.4 (Count 2). For these violations, More Than Moving for Seniors Inc, t/a Susan's Selections agrees to pay the following monetary penalties: \$125 for the violation contained in Count 1; \$125 for the violation contained in Count 2; and \$150 in board costs, for a total monetary penalty of \$400. In addition for the violations of Counts 1 and 2, More Than Moving for Seniors Inc, t/a Susan's Selections agrees to revocation of its license. Mr. Sinclair seconded the motion which was unanimously approved by members: Bennett, Roseboro, Sinclair, and Smith. As the presiding Board member, Ms. Terry was not present for the discussion or vote.

Regarding File Number 2018-00700, Daniel Pulley Dunivan, the Board members reviewed the Consent Order as seen and agreed to by Mr. Dunivan. Ms. Roseboro moved to accept the Consent Order which cites the following violations of the Board's regulations: 18VAC25-21-110.A.1.a (Count 1), 18VAC25-21-110.A.3 (Count 2), and 18VAC25-21-110.A.4 (Count 3), 18VAC25-21-100.B (Count 4). For these violations, Mr. Dunivan agrees to pay the following monetary penalties: \$250 for the violation contained in Count 1; \$50 for the violation contained in Count 2; \$50 for the violation contained in Count 3: \$100 for the violation contained in Count 4; and \$150 in board costs, for a total monetary penalty of \$600. In addition for the violations of Counts 1, 2, 3, 4 and 5, Ouinn's - Central Virginia LLC agrees to provide a copy of its current contract within thirty days of the effective date of the Consent Order. The contract must be in compliance with Board Regulations. Mr. Smith seconded the motion which was unanimously approved by members: Bennett, Roseboro, Sinclair, and Smith. As the presiding Board member, Ms. Terry was not present for the discussion or vote.

File No. 2018-00700, Daniel Pulley Dunivan

The Board reviewed the letter from Mr. Munch regarding internet auctions, and also reviewed minutes from previous meetings regarding the same. This has been an ongoing discussion periodically for many years. The Board discussed internet auctions and the protection of consumers bidding online. It was agreed by consensus that the current regulations do not address internet auctions. It was noted the regulations cannot be changed to include internet auctions unless there are changes to definitions in the statute. The Board requested staff respond to Mr. Munch's letter and thank him for his questions.

Internet Auctions

Ms. Nosbisch informed the Board that typically, the Vice-Chair assumes the position of chair and then a board member is elected Vice-Chair. Ms. Nosbisch opened the floor for nominations for Chair. Ms. Terry thanked Ms. Bennett for her service as Chair and moved that Mr. Smith, current Vice-Chair, move up as Chair. As there were no other nominations from the floor, Ms. Nosbisch closed the nominations. Mr. Sinclair seconded the motion which was unanimously approved by members: Bennett, Roseboro, Sinclair, Smith, and Terry.

Election of Chair and Vice Chair

Ms. Nosbisch opened the floor for nominations for Vice-Chair. Mr. Smith moved to nominate Mr. Sinclair as Vice-Chair. As there were no other nominations from the floor, Ms. Nosbisch closed the nominations. Ms. Terry seconded the motion which was unanimously approved by members: Bennett, Roseboro, Sinclair, Smith, and Terry.

Discussion was held on HB 883, part of the red-tape regulatory reform, which directs Department of Planning and Budget (DPB) to administer a three-year regulatory reduction pilot program aimed at reducing by 25% the regulations and regulatory requirements, as defined in the bill, of the

Department of Professional and Occupational Regulation and the Department of Criminal Justice Services by July 1, 2021. Ms. Nosbisch informed the Board a baseline of current regulations was required to be established by October 1, 2018.

Board members were provided financial statements for informational purposes.

Ms. Nosbisch noted there is a time conflict with the October 8, 2019 meeting, and requested the meeting start at 9:00 a.m. instead of 10:00 a.m. The Board agreed by consensus to change the start time of the October 8, 2019 meeting to 9:00 a.m.
