Call to Order: The meeting was called to order by the Chair, Virginia Dofflemyer, at 10:15 am. on

Agenda: The agenda was approved as presented.

Minutes: The minutes of January 16, 2003 were approved as printed.

Public Comment: Mary Ann Bergeron, Exec. Director of the Va. Assoc. of Community

Services Boards, presented an update on the activities of the VACSB including a conference on reinvestment, "A Road Map to Action" to be

held in Williamsburg on May 8-9.

Following a request by Mrs. Bergeron, it was moved, seconded and approved that the VACSB would be on each agenda of the State Board.

Human Rights: Peter McIntosh, Chair of the State Human Rights Committee, presented

their annual report highlighting several sections for the Board's attention, with specific attention to two local human rights committees, NVTC and Western, for volunteering to take on extra responsibilities to fill immediate needs. Following his presentation, the Board requested more information on the break down of abuse allegations/substantiated data contained in the

report.

A video tape on ECT was presented by Jim Bowser and previewed by the

Board.

Commmissioner's Report: Dr. Reinhard presented information on several issues including:

Regional Partnership Planning, reinvestment and the Sexually

Violent Predator Program which became effective by law on April 2, 2003. This program will be located on the North campus of the Southside Va. Training Center and the Department will be responsible for treatment.

The issue of notification of the Board in the event of incidents in the facilities which would become public knowledge was brought up. With agreement by the Commissioner, it was moved, seconded and approved that the Board Secretary would be notified of any such incidents by the Commissioner and would report those to the Board.

HIPPA Training:

Miranda Turner, Office of Risk Management, presented a video tape on the Health Insurance Portability and Accountability Act And answered questions for the Board. Jane Hickey, Office of the Attorney General, enlarged upon the HIPPA Regulations, Human Rights Regulations and State laws.

Evaluation Committee:

e: State Board Policy 6002(FIN)8886-14 Services Availability and Ability of Client to Pay Philosophy - Ray Ratke, Deputy Commissioner, and representatives of several Community Services Boards have negotiated and believe that solutions can be reached on this issue, and that no changes to this policy will be recommended. Upon recommendation of the Evaluation Committee, action on this issue was deferred.

The Committee reviewed a listing of policies prepared by staff which will be forwarded to the appropriate staff for review and recommendations prior to coming back to the committee for action.

They also recommended a list of policies for recission which the Board approved. (see attached)

Regulations:

The State Board approved for final promulgation the amended *Public Participation Guidelines* 12 VAC 35-11-1- et seq.

The Board approved for promulgation new *Regulations for Providers of Mental Health, Mental Retardation and Substance Abuse Residential Services for Children* 12VAC 35-45-10 et seq. as amended. They repealed the existing Mandatory Certification/Licensure Standards for Treatment Programs for Residential Facilities for Children and replaced them with the current regulations. Also approved was a thirty (30) day delay from the standard effective date.

Defining Directions: Doug Turner led in a discussion of directions and priorities for the future.

The Chair appointed a committee consisting of the current Evaluation Committee members (Mike Flynn, Doug Turner, Elaine McConnell and Bill Pierce) to study and make recommendations on issues that the Board may wish to take a position on, and to suggest agenda items for educational purposes.
