### **CALL TO ORDER**

Chairman Calderone called the meeting to order at 10:00 a.m.

# **SECURITY BRIEFING**

After the declaration of a quorum and introduction of members of the public in attendance, Ms. Idrissi provided the emergency evacuation procedures.

# APPROVAL OF AGENDA

Upon a motion by Mr. Dickerson and duly seconded, the members voted unanimously to approve the February 2, 2009 agenda with amendments.

### APPROVAL OF MEETING MINUTES

Upon a motion by Mr. Hunt and duly seconded, the members voted unanimously to approve the January 8, 2009 meeting minutes.

### PUBLIC COMMENT

#### 2008 APA AUDIT REPORT

Andrew Powell, CPA, MBA, Audit Director, Auditor of Public Accounts (APA) presented the Year Ended June 30, 2008 audit findings summary of VBOA financial statements. He noted that a Risk Alert to Management regarding the accounting function being moved in-house was being issued. He advised that any response to the audit findings must be submitted by Wednesday, February 4, 2009.

### IT TRANSITION REPORT

Pat Paquette, Chief Information Officer, Department of Health Professions (DHP), provided a status update regarding the IT transition to Systems Automation (SA). Ms. Paquette advised the board that DHP has a 17 member IT staff to provide support to VBOA. She stated that the SA system is a licensee based, solid, reliable system used by hundreds of agencies across the nation including several state boards of accountancy. The tentative "go live" date is February 17, 2009 and DHP staff is prepared to assist in all implementation activities. In addition, Ms. Paquette advised that the DHP database administrator (DBA) is a certified public accountant (CPA) and is actively involved in implementation of VBOA financial processes. She ensured that the new system will provide accurate financial reports. Ms. Idrissi advised the members that user acceptance training (UAT) will conclude on February 4, 2009. Finally, Ms. Paquette also advised the board that the SA system is under the umbrella of the Virginia Enterprise Application Program's (VEAP) Center for Licensing Excellence and DHP which provides a safety net for VBOA.

Mr. Dickerson, Enforcement Committee Chairman, provided a historical enforcement report to the members of the board. He advised that Jean Grant, Enforcement Manager/Investigator would provide an update to that report twice a year.

Emily Walker, Government Affairs Director, Virginia Society of Certified Public Accountants (VSCPA) advised the members that the VSCPA was alerted by a member that pending legislation regarding post employment benefits is currently being discussed by the General Assembly. Ms. Walker informed the members that the legislation is on the docket for Wednesday afternoon and she will attend.

# FEE ANALYSIS UPDATE

Mr. Holton presented the fee analysis update. He provided a summary of VBOA financials for the years ending June 30<sup>th</sup> 2006, 2007, and 2008. The following determinations were made after a comprehensive review of revenue and expenditures for the next biennium and discussion of proposed fee increases;

Re-examination Fee - \$15 Individual Licensing Fees (initial endorsement, and renewal each) - \$60 Firm Licensing Fees (initial and renewal each) - \$100 Dishonored Check Fee - \$35 Indiv Late Renewal Fee - \$100 Firm Late Renewal Fee - \$175 CPE Late Filing Fee - \$100

Upon a motion by Mr. Holton and duly seconded, the members voted unanimously to propose a VBOA fees increase. The proposed increase would be requested and promulgated through the regular, non-emergency, regulatory process. The members voting "AYE" were. Ms. Calderone, Dr. Broome, Mr. Samuel, Mr. Dickerson, Mr. Holton, Ms. Brayboy, and Mr. Hunt.

### **BOARD REPORTS**

Ms. Grant presented the Licensing Report on behalf of Mary Charity, Licensing/Examinations Manager. The VBOA Programmer has determined the cause of the failure of the electronic renewal process. He is currently in the process of manually resending notifications to each regulant that failed to receive a notice previously.

Ms. Grant provided a status report of the transition of the VBOA accounting function to DOA. This function was previously performed by DMV and later was brought in house. She stated the services will cost \$25,000 per year and will include all financial functions except GAAP financial statements. This represents a substantial reduction in cost from the previous provider and from maintaining the function inhouse.

#### Final/Approved for 2-2-09

Ms. Idrissi led the discussion regarding the Budget Acknowledgement Form requirements. No action is currently required of VBOA.

Ms. Idrissi advised the members that the VBOA Live Chat system had to be shut down last week due to hackers. She has made contact with Virginia.gov which offers free live chat services and a contract with this provider will be completed shortly. Ms. Norwood will review the contract prior to obtaining the required signature.

Ms. Idrissi also advised the members that DHP has agreed to handle VBOA web maintenance for a fee. She will submit a proposal to the Board Chair for review and comparison with the prior arrangement.

#### NASBA REPORT

Upon a motion by Mr. Dickerson and duly seconded, the board voted unanimously to endorse the nomination of Walter Davenport, CPA for consideration as Vice Chairman for NASBA.
