CALL TO ORDER

Chairman Calderone called the meeting to order at 2:03 pm.

DETERMINATION OF QUOROUM

APPROVAL OF AGENDA

Upon a motion by Chairman Calderone and duly seconded, the members voted unanimously to approve the March 30, 2009 agenda with amendments.

BOARD REPORT

Chairman Calderone requested Board approval to transfer funds. Upon a motion by Mr. Hunt, the Board authorized the transfer of \$200,000 from the VBOA Trust Fund to the VBOA Operating Fund. The motion was duly seconded and carried.
