## THE VIRGINIA BOARD OF ACCOUNTANCY Enforcement Committee Meeting Minutes February 2, 2012

The Virginia Board of Accountancy's Enforcement Committee met on Thursday, February 2, 2012, at 9960 Mayland Drive, Perimeter Center Building, 2<sup>nd</sup> Floor Commonwealth Conference Center in Hearing Room 1, located in Henrico, Virginia 23233.

The meeting convened at 10:06 a.m.

The Enforcement Committee called to order the meeting with respect to Agenda Item A, the review of the Informal Fact-Finding Conferences referenced herein as file # 2011-D0021, 2011-D0027 and 2011-D0001.

Upon completion of all Informal Fact-Finding cases, the Enforcement Committee Chairman, with respect to Agenda item F, open disciplinary cases, suggested that the Committee go immediately into closed session.

Upon a motion by Ms. Kilmer, and seconded by Ms. Calderone, the Committee approved by unanimous vote that the meeting be recessed and that the Committee immediately reconvene in closed session for the purpose of consultation on Committee matters within the jurisdiction of the Board as permitted by § 2.2-3711 A.28 of the Code of Virginia.

Upon a motion by Ms. Kilmer, and seconded by Ms. Calderone, the Committee approved by unanimous vote that the closed meeting, as authorized by § 2.2-3711 A.28 of the <u>Code of Virginia</u>, be adjourned, and that the Committee immediately reconvene in open public meeting.
