John Doe - Pre License

Hello,

Can you include this as public comment for the next meeting of board for contractors? The ineptness of the Virginia Board For Contractors needs to be addressed. Why didn't the board for contractors, with all it's supposed regulation and policing of contractors and making sure that they're responsible for those they hire, take action to allow alternatives when the exam vendor that it was responsible for, shut down because of Covid? Instead the board just told people to contact the exam vendor as if that vendor was the one with the ultimate responsibility. Is this how the board expects contractors to deal with their employees and subcontractors when a customer complains? If not then why is there a different standard for the board? The board was authorized to waive regulations and they should have allowed out-of-state companies with similar licenses is at least temporary license to operate instead of telling people to contact their exam vendor. Now, the board is changing back and forth at its meetings, what license is required for a particular type of contracting. This is a weighty thing, and not something members should come and vote back and forth on at meetings. Recently the board finally announced action to allow time and materials contracting which is commonly done throughout the industry and has been done this way for years in certain types of cases. The board believes that no administrative oversight of this decision is required and it can make this change on a whim at it's quarterly board meetings even though if it was competent it should've made this change years ago.

Recently, it was mentioned at a meeting, that attendees of the remedial education programs remarked that they wish that would have been offered the course pre-licensure because of the number of things they had not been made aware of. Pathetically, the boards only response was a member saying that offering this to all contractors would be too expensive. It is unthinkable that the board would be bringing action against people, and those people expose that there's a problem with pre-license education, and the board administrator (while still being content to continue his enforcement) are unwilling to address the problem with people making errors in large part due to ignorance. The board has a responsibility to promulgate the rules (not just enforce them) and this is evidence of failure of that mission. This writer has taken the board approved 8 hour contractor license business class and finds it to be woefully inadequate and useless. It's shameful that the board has approved this, then been told by contractors who have gotten into trouble that it's inadequate, and only mentioned they can't afford to do better. If the board can't afford to do its job properly it may be better that it just not do it at all.

Why doesn't the board at least as a starting point video record some of its training and put it online for free, so that those who wish to have it could review it before they make mistakes? This would at least give companies an opportunity to not only have their qualified people but their regular employees be more familiar with the rules that they must operate under. I think the board needs a serious review of its

Hi Marjorie,

I hope you are doing well.

I am not sure if you remember me; we communicated several times in the past while with my previous employers (most recently with Spotsylvania County). We are currently in the midst of the 2021 Virginia Code Development Cycle. During one of the recent Study Group (SG) meetings a question came up regarding the required license for the installation of an NFPA 13D sprinkler system. The SG members are interested in DPOR's position on this matter. As per the DPOR Regulations, "Fire sprinkler contracting" (Abbr: SPR) means the service that provides for the installation, repair, alteration, addition, testing, maintenance, inspection, improvement, or removal of sprinkler systems using water as a means of fire suppression when annexed to real property. This specialty does not provide for the installation, repair, or maintenance of other types of fire suppression systems. The PLB classification allows for the installation of systems permitted to be designed in accordance with the plumbings provisions of the USBC. This specialty may engage in the installation of backflow prevention devices in the fire sprinkler supply main and incidental to the sprinkler system installation when the installer has received formal vocational training approved by the board that included instruction in the installation of backflow prevention devices. Also, in accordance with the DPOR Regulations, the "Plumbing contractors" (Abbr: PLB) classification "...may install sprinkler systems permitted to be designed in accordance with the plumbing provisions of the USBC (when the installer has received formal vocational training approved by the board that included instruction of installation of sprinkler systems). Section P2904.1 of the 2018 Virginia Residential Code (VRC) reads, in part, The design and installation of residential fire sprinkler systems shall be in accordance with NFPA 13D, 13, 13R or Section P2904, which shall be considered to be equivalent to NFPA 13D." (emphasis added) It appears that given the above emphasized text, some of the SG members are interpreting the DPOR Regulations to allow the PLB classification to install NFPA 13D sprinkler systems. The other SG members are interpreting the DPOR Regulations to require a SPR classification for the installation of all sprinkler systems, with the exception of those systems that are specifically designed in accordance with Section P2904 of the VRC (which is part of the USBC). Or, otherwise stated: the PLB classification is only allowed to install sprinkler systems designed in accordance with Section P2904 of the VRC; and a SPR classification is required for the installation of all other fire sprinkler systems (i.e.: NFPA 13D, NFPA 13R, NFPA 13)-

If you could clarify DPOR's position on this matter, it would be greatly appreciated and of assistance during the SG discussions. Thank you in advance for your assistance with this. Have a great rest of the week.

Virginia Codes

Marjorie King, Board Administrator, reply by email.

It's my understanding that the prescriptive design requirements in question are not contained within the plumbing code (IPC) but rather in Chapter 29 of the residential building code (IRC) specifically, in Section P2904. The only sprinkler systems within the scope of the PLB Classification are those designed in accordance with those prescriptive requirements. Although such a system is recognized by the IRC as equivalent to an NFPA 13D system, the design is not the same. The Board's regulations do not have an exception to allow the PLB Classification to install systems designed in accordance with NFPA Standards (NFPA 13, NFPA 13D, NFPA 13R). When the IRC model code was revised to require sprinklers in single-family, two-family and townhouses in the 2009 edition, P2904 was created as a design standard. The Board revised the PLB and SPR definitions in anticipation that some plumbers may want to do this type of work even though Virginia has maintained these systems as optional and not mandatory to this point. Again, NFPA systems require the SPR specialty.

A recommendation to the Board was made by Mr. O'Dell seconded by Mr. Hux to accept the response given by Ms. King.

Commenter: Historic Contracting, LLC Modification to allow T & M or cost plus contracts

To whom it may concern, \(\int\)

We are very concerned, as many of my fellow builders are, with the building materials market volatility. Pricing has escalated far beyond controllable means. We have in excess of 2.5 million of new construction residential homes to build in the Richmond area and will not issue our contracts to our investor clients as we cannot guarantee that the contract amount will hold by the time the materials are delivered to the job site. We are planning to add language to our contract that would allow for the contract amount to be modified to recapture the material cost increases between the time of contract execution and actual delivery dates, plus standard and reasonable overhead and profit. Conversely, should the material amount drop below the original contracted amount then a credit would be issued to the client. In my opinion, T & M would not be practical on large projects. Very accurate cost accounting methods would have to be adhered to, insuring the process is accurate and fair to both parties. Copies of all material receipts and payroll logs with time sheets would have to be used and all of this only adds to the operating overhead and accounting of the project. If we are to be permitted to use the contract language that I am proposing, it would only be used when suppliers will not or cannot hold firm to their quoted material amounts. At this time several of our larger suppliers are holding their present quotes until March

15, 2022. Material need not be delivered to hold the price, but a purchase order issued and the quote signed off and accepted by us, the contractor and them, the supplier. We are all working through very challenging times and we all will have to work together for a successful and reasonable outcome. I appreciate all of your efforts to recognize the negative forces that we are faced with as building contractors and the fact that you, as a governing body, are willing to create an open forum to entertain ideas and suggestions that will clear a path for our collective continued success.
