1 MR. MATHEWS: Good Afternoon. I am Kyle Mathews,
2 a Regulatory Analyst with the Board for Contractors.
3 This is a public hearing being held at the Perimeter
4 Center in Richmond, Virginia. This hearing is held
5 pursuant to the Administrative Process Act, Section
6 2.2-4007 of the Code of Virginia, for the purpose of
7 receiving public comment on the proposed amendments to
8 the Board for Contractors Regulations published in the
9 Virginia Register on October 21, 2024, Volume 41, Issue
