Approval of Minutes

BOARD WORKING PAPERS

1 The State Board of Elections (“the Board”) meeting was held on Monday,
2 November 18, 2024 in the Martha Brissette Conference Room of the Washington
3 Building in Richmond, Virginia. The meeting also offered public participation
4 through electronic communication so the remote public could view and hear the
5 meeting. In attendance: John O’Bannon, Chairman; Rosalyn R. Dance, Vice Chair;
6 Georgia Alvis-Long, Secretary; and Delegate Donald Merricks, member
7 represented the State Board of Elections (“the Board”). Matthew Weinstein,
8 member attended the meeting electronically (At 1:50 P.M.). Susan J. Beals,
9 Commissioner, represented the Department of Elections (“ELECT”), and Andrew
10 Murphy and Dennis Polio represented the Office of the Attorney General (“OAG”).
11 Chairman O’Bannon called the meeting to order at 1:00 P.M.

12 The first item of business was the Approval of the Minutes from the
13 September 3, 2024 and November 5, 2024 Board Meetings, presented by Secretary
14 Alvis-Long. Secretary Alvis-Long moved *that the Board approve the minutes from*
15 *the September 3, 2024 and November 18, 2024 Board Meetings*. Vice Chair Dance
16 seconded the motion and the motion passed unanimously. A roll call vote was
17 taken:

23 Chairman O’Bannon opened the floor to public comment. Ann Grigorian
24 and John Lareau addressed the Board.

25 The second item of business was the Commissioner’s Report, presented by
26 Commissioner Beals. Commissioner Beals expressed her appreciation to the 133
27 General Registrars, their staff, the 399 Electoral Board members, and the thousands
28 of Officers of Election for the 2024 Presidential Election. The Commissioner stated
29 that ELECT is currently in the post-election period as ELECT is triple checking the
30 submitted abstracts of votes. Commissioner Beals stated that ELECT will oversee
31 the risk-limiting audit of the U.S. Senate race in every locality on Wednesday,
32 November 20, 2024, and one Congressional race on Thursday, November 21, 2024
33 and Friday, November 22, 2024. The Commissioner also informed the Board that a
34 drawing will be conducted to determine which Campaign Finance accounts will be
35 reviewed starting in January.

36 The third item of business was the Risk Limiting Audit (“RLA”) A.
37 Selecting a Congressional District Race for RLA; Generating the Random Seed
38 Number for RLA; and Setting the Risk Limit. B. Approving Local Races for RLA,

39 Setting the Risk Limit, Generating the Random Seed Number for RLA and Setting
40 the Dates for both RLAs, presented by Matthew Abell, Election Service Senior
41 Advisor and Claire Scott, ELECT Policy Analyst. *This memo is in the Working*
42 *Papers for the November 18, 2024 Meeting.* Vice Chair Dance moved *that the*
43 *State Board of Elections randomly select a Congressional District as described in*
44 *the memo presented.* Secretary Alvis-Long seconded the motion and the motion
45 passed unanimously. A roll call vote was taken:

Re: Certification of Results for the November 5, 2024 General and Special Elections

Applicable Code Sections:

- Va. Code § 24.2-679.A. "The State Board shall meet by the first Monday in December to ascertain the results of the November election."
- Va. Code § 24.2-680 "Subject to the requirements of § 24.2-948.2, the State Board shall without delay complete and transmit to each of the persons declared to be elected a certificate of his election, certified by it under its seal of office."

Background:

- Upon completion of the election, local general registrars (GRs) entered all relevant election data into the Election Night Reporting software and the Virginia Election and Registration System (VERIS).
- In accordance with Va. Code § 24.2-671, within ten days after the election, local Electoral Boards conducted provisional ballot meetings and canvasses to ascertain and certify election results for their localities.
- Upon completion of canvass, the GRs forwarded their locality's certified Abstracts of Votes (Abstracts) and, when applicable, Write-Ins Certifications, to the Department of Elections (ELECT).
- Upon receipt of the Abstracts and Write-Ins Certifications, to ensure accuracy and completion, ELECT staff:
 - Confirmed all required Abstracts and Write-Ins Certifications were completed and submitted.
 - Reviewed votes cast, ballots cast, and turnout comparison, using validation errors found by the Election Night Reporting software and others found by manual analysis, and asked localities to resolve and/or explain any issues identified.
 - Ran Turnout vs. Voting Credit reports and asked localities to resolve and/or explain any issues identified.
 - Compared the results listed in the Abstracts and Write-Ins Certifications to the results entered in Election Night Reporting software to ensure accuracy.

Suggested Motion:

“After reviewing the Abstracts of Votes Cast in the 2024 November General and Special Elections, I move that the Board certify the statements to be correct and sign the statements and certificates of election.”

Closed Session

1. **Into closed session:** “Pursuant to Virginia Code Section 2.2-3711(A)(7), I move that the Board go into closed session for the purpose of discussing pending threatened litigation. In accordance with Section 2.2-3712(F), Susan Beals, Commissioner of Elections, Andrew Murphy and Dennis Polio of the Office of the Attorney General, and Steve Koski, ELECT Compliance Advisor will attend the closed session because their presence will reasonably aid the Board in its consideration of the subject of the meeting.”

a. After the motion is seconded, the Board members must vote (must be a roll call vote).

2. **Out of closed session:** “I move to reconvene the meeting in open session, and take a roll call vote certifying that to the best of each member’s knowledge (i) only such public business matters lawfully exempted from open meeting requirements under this chapter and (ii) only such public business matters as were identified in the motion by which the closed meeting was convened were heard or discussed by the State Board of Elections”

a. After the motion is seconded, poll the members for each vote. Each member must vote individually and not as a group.
