Ms. Toliver reported that the Committee found that while providing treatment to Patient A on August 4, 2009, Dr. Schuyler failed to perform a post-operative check by direct observation after extracting tooth #2. A subsequent provider determined that, during his extraction of Patient A's tooth #2, a surgical bur separated and became lodged into the root structure of tooth #3, as evidenced in a radiograph taken on August 8, 2009.

The sanction reported by Ms. Toliver was that Dr. Schuyler shall pay a \$1,000 monetary penalty.

Dr. Rizkalla moved to adopt the decision of the Committee. The motion was seconded and passed.
