Background:

Ms. Jasmine Moawad was seeking to qualify to have her name printed as an official candidate on the November 2018 General Election ballot for Senate of Virginia, District 13. Currently, Ms. Moawad has 90 validated signatures. Pursuant to Va. Code § 24.2-506, candidates for Senate of Virginia are required to collect and have validated 250 signatures.

Ms. Moawad is deficient 160 qualified signatures.

Pursuant to 1VAC20-50-30(G), Ms. Moawad must submit a list of rejected signatures to be reviewed and the specific reason for each signature's reconsideration at least two (2) business days prior to the date of the appeal.

Ms. Moawad failed to submit a list of signature for reconsideration; thus, Ms. Moawad's original disqualification stands and she will not have her name printed as an official candidate on the November 2018 General Election ballot for Senate of Virginia, District 13 (*see* Va. Code § 24.2-506 and 1VAC20-50-30). This determination is final and not subject to appeal.

Appeal for the Petition of Qualified Voters per Virginia Code §24.2-506.

Thank you kindly for the official notice, dated 1st July 2019, from Mr. Dave Nichols which highlights a discrepancy from the Election Services. Mr. Nichols' letter states: "You filed 26 petition pages containing 90 accepted signatures." (Copy enclosed).

On 26 June 2019, Sean Mulligan of SMulligan@pwcgov.org wrote an email stating:
"We have fully processed 349 of the 496 total signatures and only 94 signatures were acceptable."
(Copy enclosed).

It is concerning that Mr. Mulligan stopped counting and sent his notice without finishing counting. His presumptive counting is concerning. It is concerning that there is a discrepancy between the numbers presented by Mr. Mulligan and Mr. Nichols. I hereby request each list name that qualify as "accepted signatures" from Mr. Mulligan and Mr. Nichols.

The Code of Virginia states: §24.2-506. Petition of qualified voters required; number of signatures required; certain towns excepted.


A. The name of any candidate for any office, other than a party nominee, shall not be printed upon any official ballots provided for the election unless he shall file along with his declaration of candidacy a petition; therefore, on a form prescribed by the State Board, signed by the number of qualified voters specified in this subsection after January 1 of the year in which the election is held and listing the residence address of each such voter. Each signature on the petition shall have been witnessed by a person who is himself a legal resident of the Commonwealth and who is not a minor or a felon whose voting rights have not been restored and whose affidavit to that effect appears on each page of the petition. Each voter signing the petition may provide on the petition the last four digits of his social security number, if any; however, noncompliance with this requirement shall not be cause to invalidate the voter's signature on the petition."



Background:

Mr. Elliot Harding is seeking to qualify to have his name printed as an official candidate on the November 2018 General Election ballot for Senate of Virginia District 25. Currently, Mr. Harding has 247 validated signatures. Pursuant to Va. Code § 24.2-506, candidates for Senate of Virginia are required to collect and have validated 250 signatures.

Mr. Harding is deficient three (3) qualified signatures.

Pursuant to 1VAC20-50-30(G), Mr. Harding must submit a list of rejected signatures to be reviewed and the specific reason for each signature's reconsideration at least two (2) business days prior to the date of the appeal. The provided list totaled three (3) rejected signatures and reasons for reconsideration. ELECT reconsidered all three (3) signatures.

ELECT Recommendations

1. Page 19, Signature #6

Candidate's reason for acceptance:

“Ms. Lucy Carr Jones was registered to vote at the address listed under her maiden name of “Lucy Carr” at the time she signed the petition. She is a registered voter at the provided address and her name is clearly legible on the petition. Since signing the petition, she has re-registered under her married name and is now easily identified as being the same Lucy Jones. Additionally, she would have been permitted to vote on the day she signed the petition and was qualified to vote in the November 5, 2019 General Election. The Registrar's office for the City of Charlottesville since stated that Ms. Jones' signature should be counted and should be allowed at this stage, as Ms. Jones submitted a new registration to reflect the change in name and she was the qualified voter at that address.”

ELECT Recommends: The SBE validate this signature and count this signature towards the candidate's total number of petition signatures due to the reasoning provided by the candidate.

2. Page 22, Signature #2

Candidate's reason for acceptance:

“Mr. Witkower is a registered voter at the provided address, he signed the petition on a date that was on or before the date of notarization, and his name is clearly legible on the petition. It is my understanding that Mr. Witkower registered to vote at the provided address prior to signing the petition but after the closing of the rolls or when “books were closed” for voters to register for the June 11, 2019 Primary. Though he could not vote in the June 11th Primary, he was a qualified voter for the relevant office being sought in the November 5, 2019 General Election. The voter rolls close three weeks in advance of the primaries. To bar Mr. Witkower's signature on this petition would set a precedent that would limit the ability for otherwise qualified voters to have a say as to who is on the ballot for November Elections just because these voters are not able to vote in the Primary. This would effectively make all voter information static three weeks in advance to the relevant filing deadline for a reason that is entirely unrelated to the ballot and election. Mr. Witkower's signature must be counted as a registered and qualified voter.”

ELECT Recommends: The SBE validate this signature and count this signature towards the candidate's total number of petition signatures due to the reasoning provided by the candidate. Further, the registration deadline was in effect due to the primary that occurred on June 11, 2019. If the candidate was gathering petitions in a locality without a primary, there would be no registration deadline and the signer's voter registration application would have been processed timely and the signature counted.

3. Page 26, Signature #7

Candidate's reason for acceptance:

“Mr. Jon Bright is a registered voter at the provided address, was registered for that address at the time he signed the petition, and he signed the petition on a date that was on or before the date of notarization. Despite the registrar's crossing out of his name and address, his information is clearly legible on the petition. His signature must be counted as a qualified signature.”

ELECT Recommends: The SBE validate this signature and count this signature towards the candidate's total number of petition signatures due to the reasoning provided by the candidate.


To Whom It May Concern:

Signature Rejections

Pursuant to Va. Code § 24.2-506, the following information and attached document details signatures rejected and the appeal process.

You should review the attached petition document as it provides information regarding validated and rejected signatures.

How to read the Petition Signatures report.

- REF:** Petition page and line number the signer's signature is on
NAME: Petition signer's name
CITY: Petition signer's city
ZIP: Petition signer's zip code
SIGNED: Date the petition signer signed the petition
LOCALITY: Petition signer's locality of registration
STATUS: Acceptance or the reason for rejection of the signature
- If a signature has "accepted," it was accepted. Any other status means the signature was rejected.
- PG:** Petition page was accepted or rejected

When determining the validity of signatures, a reason code must be provided by the general registrar. The following chart lists the rejection reason codes and meaning.

Petition Status	Meaning
Info Mismatch	A matching registration was found; however, the address provided by the voter is outside of the precinct district.
Registered, Not Qualified	There are several reasons a registered voter's signature may not qualify; including, but not limited to: the petition signature was dated on or before January 1 of the election year, the petition signer provides a date after the date of notarization, etc.
Cannot Identify	The individual's registration cannot be identified.
Illegible	The individual's information cannot be read on the petition.
Duplicate	The individual's signature was already accepted.

Appeal Process

Pursuant to 1VAC20-50-30, the following document details the information that you must provide when appealing a disqualification to candidacy based on insufficient petition signatures.

You bear the burden of proof in establishing a sufficient number of signatures from qualified voters were timely submitted.

You must submit a list containing the rejected signatures you wish for ELECT to review.

- Each signature must have a specific reason for why it should be reconsidered by the State Board.
- This list must be submitted **July 9, 2019 by 5:00 PM**.
- This list may be submitted in person at the Department of Elections or via email at ea@elections.virginia.gov.

An appeal will not be held and the original disqualification will stand, if:

- You do not submit this list by the deadline; OR
- You submit a list without a sufficient number of names and the reason(s) for reconsideration to make up the number of signatures by which you were deemed deficient.

You may submit evidence for your appeal.

Evidence that may be submitted:

- Documents clarifying the status of persons whose signatures were rejected for lacking proper registration status or residence;
- Documents establishing the age of majority for any signer who was listed as ineligible due to status of being a legal minor; OR
- Affidavits from persons whose signatures were rejected due to illegibility that attest to their identity. The affidavits should state the person's name, residence address, and, if possible, a reasonable description of the location where approached by the circulator to sign the petition.

You may not submit documents establishing that a petition signer became registered or updated his voter registration status to the address provided upon the petition after the established candidate filing deadline for the office sought (*see* 1VAC20-50-30).

An individual signature being reconsidered during the appeal will only count towards your required number of signatures if a majority of the Board agrees that sufficient evidence exists for their inclusion.

All determinations by the SBE are considered final and not subject to further appeal.

She is a registered voter at the provided address and her name is clearly legible on the petition. Since signing the petition, she has re-registered under her married name and is now easily identified as being the same Lucy Jones. Additionally, she would have been permitted to vote on the day she signed the petition and was qualified to vote in the November 5, 2019 General Election. The Registrar's office for the City of Charlottesville since stated that Ms. Jones' signature should be counted and should be allowed at this stage, as Ms. Jones submitted a new registration to reflect the change in name and she was the qualified voter at that address.

2.) Page 22, Signature # 2, Mr. Judah Witkower, 982 Sutton Ct., Charlottesville, Va.

Registrar's Stated Reason for Rejection: "Registered Not Qualified"

Candidate's Reason for Acceptance: Mr. Witkower is a registered voter at the provided address, he signed the petition on a date that was on or before the date of notarization, and his name is clearly legible on the petition. It is my understanding that Mr. Witkower registered to vote at the provided address prior to signing the petition but after the closing of the rolls or when "books were closed" for voters to register for the June 11, 2019 Primary. Though he could not vote in the June 11th Primary, he was a qualified voter for the relevant office being sought in the November 5, 2019 General Election. The voter rolls close three weeks in advance of the primaries. To bar Mr. Witkower's signature on this petition would set a precedent that would limit the ability for otherwise qualified voters to have a say as to who is on the ballot for November Elections just because these voters are not able to vote in the Primary. This would effectively make all voter information static three weeks in advance to the relevant filing deadline for a reason that

is entirely unrelated to the ballot and election. Mr. Witkower's signature must be counted as a registered and qualified voter.

3.) Page 26, Signature # 7, Mr. Jon Bright, 109 Altamont Cir., Charlottesville, Va.

Registrar's Stated Reason for Rejection: "Registered Not Qualified"

Candidate's Reason for Acceptance: Mr. Jon Bright is a registered voter at the provided address, was registered for that address at the time he signed the petition, and he signed the petition on a date that was on or before the date of notarization. Despite the registrar's crossing out of his name and address, his information is clearly legible on the petition. His signature must be counted as a qualified signature.

Code § 24.2-511.A – “The state, district, or other appropriate party chairman shall certify the name of any candidate who has been nominated by his party by a method other than a primary for any office to be elected by the qualified voters of (i) the Commonwealth at large, (ii) a congressional district or a General Assembly district, or (iii) political subdivisions jointly electing a shared constitutional officer, along with the date of the nomination of the candidate, to the State Board not later than five days after the last day for nominations to be made. The State Board shall notify the general registrars of the names of the candidates to appear on the ballot for such offices.”

Background:

Issue #1: After publicly posting a list of candidates for Virginia House of Delegates, a local General Registrar contacted the Department of Elections about the lack of a Republican candidate for the House of Delegates 30th District (HOD-30). Upon examination of the records, it was determined that the Department had not received a Party Certification of Non-Primary Candidate (ELECT-511) form nor had it received any candidate paperwork (Certificate of Candidate Qualification (SBE-501) or Statement of Economic Interests (SOEI)) from any Republican candidates in HOD-30. The attached documents related to Issue #1 are presented for the Board's consideration of accepting the ELECT-511 after the June 17, 2019 deadline.

Issue #2: After publicly posting a list of candidates for Virginia House of Delegates, the Department of Elections was contacted about the lack of a Democratic candidate for the House of Delegates 76th District (HOD-76). Upon examination of the records, it was determined that the Department had not received a Party Certification of Non-Primary Candidate (ELECT-511) form for an HOD-76 Democratic candidate, but had received an SBE-501 and SOEI from a purported candidate. The attached documents related to Issue #2 are presented for the Board's consideration of accepting the ELECT-511 after the June 17, 2019 deadline.





Dear Members of the State Board of Elections:

We write on behalf of our client, Clinton Jenkins, in connection with his nomination for the Virginia House of Delegates in the 76th House of Delegates District. Mr. Jenkins is the duly chosen nominee of the Democratic Party in the 76th District and was certified as such by the Chair of the Democratic Nominating Committee for the 76th District. Due to a typographical error, the State Board of Elections appears not to have received the certification. Just last week, in nearly identical circumstances, the State Board voted to allow Delegate Terry Kilgore on the ballot even though the State Board had not received the certification of his nomination. Accordingly, Mr. Jenkins' name should appear on the general election ballot as the Democratic nominee for the 76th District.

A. Mr. Jenkins is the duly chosen nominee of the Democratic Party for the 76th District.

On March 21, 2019, the Democratic Nominating Committee for the 76th District issued a Call to Caucus, informing potential candidates for the Democratic nomination for the House of Delegates in the 76th District of the rules and requirements for filing their candidacy, including the filing deadline of May 3, 2019. On May 3, 2019, Mr. Jenkins filed the requisite paperwork to run as a candidate in the 76th House of Delegates District. Mr. Jenkins was the only candidate to file the requisite paperwork by the deadline specified in the Call to Caucus. Accordingly, by the terms of the Call to Caucus, Mr. Jenkins automatically became the Democratic nominee on May 3, 2019. *See also* Va. Code. Ann. § 24.2-526 (“Whenever within the time prescribed by this article there is only one declaration of candidacy in a political party for the nomination for any office, the person filing the declaration shall be declared the nominee of the party for the office for which he has announced his candidacy and his name shall not be printed on the ballot for the primary.”).

B. The Democratic Nominating Committee certified Mr. Jenkins as the nominee in the 76th House District on May 13, 2019.

Virginia law provides that “[t]he state, district, or other appropriate party chairman shall certify the name of any candidate who has been nominated by his party by a method other than a primary for any office to be elected by the qualified voters of ... a General Assembly district ... along with the date of the nomination of the candidate, to the State Board not later than five days after the last day for nominations to be made.” *Id.* § 24.2-511(a). The statute goes on to provide that “[t]he State Board shall notify the general registrars of the names of the candidates to appear on the ballot for such offices.” *Id.*

On May 13, 2019, Leslie Rinaldi, the Chairwoman of the Democratic Nominating Committee for that district, sent an email to Leslie Williams at the Virginia Department of Elections, certifying that Mr. Jenkins was the Democratic nominee in the 76th House District. *See* Exhibit A. According to her affidavit, Chairwoman Rinaldi had completed ELECT Form 511 to memorialize the certification and intended to attach it to the sent email, but inadvertently omitted it. *See* Exhibit B.¹ Chairwoman Rinaldi also appears to have entered a non-working email address for Ms. Williams, using williams.leslie@elections.virginia.gov instead of leslie.williams@elections.virginia.gov. The General Registrar of the City of Suffolk apparently received the email. But the State Board of Elections did not, likely due to this use of a non-working email address. Ms. Rinaldi did not receive a bounceback or automated response indicating that such an email address did not in fact exist. Had she received such a response, there would have been ample time to correct the error.

C. Mr. Jenkins’ name should be included on the general election ballot as the Democratic nominee in the 76th House District.

Mr. Jenkins’ name should be included on the general election ballot as the Democratic nominee in the 76th House District, for several reasons.

First, Mr. Jenkins complied with all legal requirements that state law imposed on him. He timely completed and filed all of the requisite candidate paperwork. He even attempted to submit the completed Form 511 in person to the Department of Elections on June 3, 2019, but was informed by Department of Elections personnel that this was not permissible.

Second, there is no question that Mr. Jenkins is the duly selected nominee of the Democratic Party for the 76th House District. As the only candidate who submitted the requisite paperwork

by the deadline set forth in the Call to Caucus, Mr. Jenkins automatically became the nominee on May 3, 2019.


Third, Chairwoman Rinaldi certified Mr. Jenkins as the nominee in an email sent to the State Board of Elections and the City of Suffolk General Registrar on May 13, more than one month before the statutory deadline. Chairwoman Rinaldi's inadvertent use of a non-working email address for Ms. Williams does not negate the fact that she certified the nomination to the State Board by the statutory deadline. Just two weeks ago, the State Board of Elections voted to allow Del. Terry Kilgore's name to appear on the general election ballot even though the State Board of Elections had not received his certification of nomination by the statutory deadline. In that case, the State Board did not have any documentary evidence that the certification had been timely submitted and no government official had received the certification by the statutory deadline. Here, conversely, we have provided documentary evidence that the certification had been timely submitted (albeit to a non-working email address) and another government official (the Suffolk County General Registrar) timely received it. Thus, the State Board's apparent non-receipt of the certification email constituted harmless error.

Finally, Virginia law appears to contemplate this scenario and provides a remedy for it – State Board certification of the nominee. The statutory provision governing certification of nominees for *local* office specifically provides that if the chairperson fails to certify the party's nominee to the State Board, "the State Board shall declare that the candidate is the nominee of the particular party and direct that his name be treated as if certified by the party chairman." *Id.* § 24.2-511(b). While this provision does not specifically govern certification of nominees for the House of Delegates, the State Board exercised this authority in allowing Mr. Kilgore's name to appear on the ballot. The State Board should do the same here.

For the reasons set forth above and consistent with your decision in the matter of Delegate Kilgore, we respectfully request that you place Mr. Jenkins' name on the general election ballot as the Democratic Party nominee for the 76th House District.

4. I filed for nomination on May 3rd, 2019, prior to the filing deadline. On May 6th, 2019, I was informed that because I was the only candidate to file by the deadline, the caucus would be canceled, and that I would thereby be declared the Democratic nominee; this was confirmed on May 9th, 2019.
5. Before and after receiving the nomination, I have complied with all of the filing requirements and other legal requirements for a House of Delegates candidate.
6. On May 13th, 2019, Leslie Rinaldi, as Chairwoman of the Democratic Nominating Committee, sent an email to Leslie Williams, an Elections Administrator at the Virginia Department of Elections, as well as to the Suffolk City General Registrar, certifying me as the Democratic nominee in the 76th House of Delegates District. I was copied on this email and received the email at the time that it was sent.
7. The email was sent to Ms. Williams using the email address williams.leslie@elections.virginia.gov. On July 2nd, I learned that her correct email

6. The email was sent to Ms. Williams using the email address williams.leslie@elections.virginia.gov. On July 2nd, I learned that Ms. Rinaldi's certification of Mr. Jenkins had not been received by the Department of Elections.
7. It was my understanding that Ms. Rinaldi's email served to officially certify Mr. Jenkins as the Democratic nominee in the 76th House of Delegates District over a month prior to the statutory deadline for certification.
8. By denying Mr. Jenkins' placement on the ballot in the 76th House of Delegates District for the general election, the nomination of the Democratic Party of Virginia, the 76th House of Delegates Democratic Nominating Committee, and the Democratic voters of the 76th House of Delegates District would be negated by one minor typographical mistake in an email address.
9. Clinton L. Jenkins was properly nominated by the Democratic Nominating Committee for the 76th House of Delegates District, and I therefore request, as a Virginia voter and as the Chair of the Chesapeake Democratic Committee, that he be placed on the ballot for the November 5th, 2019 General Election as the Democratic Nominee in the 76th House of Delegates District.

1. I am the Chairwoman of the 76th House of Delegates District Democratic Nominating Committee.
2. On March 21st, 2019, the Democratic Nominating Committee for the 76th House of Delegates District issued a call to caucus for the purpose of nominating a Democratic candidate for the 2019 general election in the 76th House of Delegates District. The caucus was scheduled for May 18th, 2019.
3. The Democratic Nominating Committee set a filing deadline of May 3rd, 2019. In the event that only one candidate filed for nomination, the caucus would be canceled, and that one individual would be declared the Democratic nominee.

6. The email was sent to Ms. Williams using the email address `williams.leslie@elections.virginia.gov`. I did not receive a bounceback or automated response to my initial email, and therefore was not aware that the email had been sent to the incorrect address. On July 1st, I learned that Ms. Williams' correct email address was `leslie.williams@elections.virginia.gov`, and that my certification of Mr. Jenkins had not been received by the Department of Elections.
7. It was my understanding that I had complied with the statutory requirement, and as Chairwoman of the Democratic Nominating Committee, had officially certified Mr. Jenkins as the Democratic nominee in the 76th House of Delegates District over a month prior to the statutory deadline for certification.
8. By denying Mr. Jenkins' placement on the ballot in the 76th House of Delegates District for the general election, the nomination of the Democratic Party of Virginia, the 76th House of Delegates Democratic Nominating Committee, and the Democratic voters of the 76th House of Delegates District would be negated by one minor typographical mistake in an email address.
