DISCUSSION: Dr. Zackrison appeared before the Board in person in accordance with the Board's Amended Notice of Formal Hearing dated December 11, 2019. Dr. Zackrison was represented by Jacques G. Simon, Esquire and Dan Alpert, Esquire.

PRELIMINARY MATTERS: 1 - The Chair ruled on Mr. Simon's February 18, 2020, letter regarding *Scheduling and Duration matters . . .*; *Objection to scheduling order*; *Objection to designation of Rick Place, M.D., and Pemmaraju Saleena Dankin as Expert witnesses*; *Objection to documentary evidence in Vol. 18*; and the Commonwealth's Response letter to same dated February 19, 2020. The Chair overruled all issues and objections raised in Mr. Simon's February 18, 2020 letter.

2 – The Chair ruled on the Commonwealth’s February 7, 2020, *Objections to Respondent’s Evidentiary Resubmission*. The Chair overruled the Commonwealth’s objection and admitted Respondent’s CD resubmission into evidence.

3 – Mr. Simon made a motion to disqualify Dr. Ali and Dr. O’Connor from the panel based on bias. Mr. Simon also asked for permission to poll the panel members as to their participation in the summary suspension call; and if any participated, he motioned they be removed from the panel based on bias.

In accordance with Virginia Code § 54.1-110(B), Drs. Ali and O’Connor stated they could both be fair and impartial in considering the matter before the Board. The panel members first determined that Dr. Ali should not be disqualified, pursuant to Virginia Code § 54.1-110(B). The panel members then determined that Dr. O’Connor should not be disqualified, pursuant to Virginia Code § 54.1-110(B).

The Chair overruled Mr. Simon’s motion to poll the panel.

Mr. Simon motioned again to *voir dire* the panel.

The Chair overruled Mr. Simon’s motion to *voir dire* the panel.

4 – The Commonwealth motioned to sequester the witnesses. The Chair granted the Commonwealth’s motion to sequester the witnesses.

5 – Mr. Simon noted his objection to admission of Commonwealth’s Exhibit 26.

The Chair overruled the objection.

6 – Mr. Simon noted his objection to expert designation of Dr. Dakin.

The Chair noted this objection had already been ruled on previously.

The Board received evidence and sworn testimony from witnesses called by the Commonwealth regarding the allegations in the Notice.

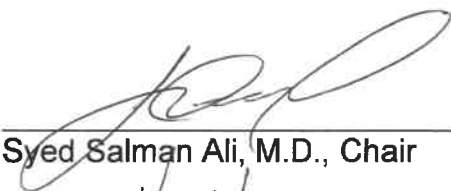

VOTE: The vote was unanimous.

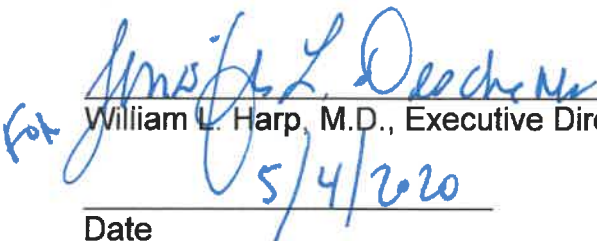

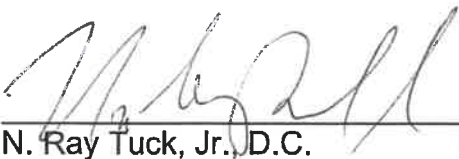

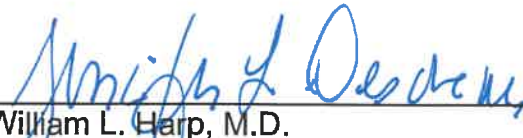
