Call to order:	The meeting was called to order at 3:22 p.m. by the Chair, Dr. Samuel Bartle.	
Introductions:	Everyone around the room introduced themselves.	
Approval of the minutes from January 5, 2017 meeting:	A motion was made to review and approve the minutes. The motion was moved by Dr. Kahler and seconded by Petra Connell. All committee members were in favor. The minutes were approved as submitted.	The minutes were approved as submitted.
Chair Report –Dr. Samuel Bartle:	Dr. Bartle discussed the ongoing changes in medical health coverage and how this will have an impact on children who are covered by Medicaid. This will particularly affect pre-hospital care and emergency care. Kae mentioned that some school divisions’ bill for services and some do not. But this will affect the schools that do. Dr. Kahler said that if we lose the waiver possibility, that’s huge. Any services covered by waivers, the parents would have to pay out-of-pocket. David Edwards discussed funding for EMS for Children. He explained that the federal funding is still at 57.53%.	
OEMS Report –Cam Crittenden/Dr. George Lindbeck:	Cam reported that the Trauma Division is now fully staffed. The two data positions have been filled by contractors and the Trauma Critical Care/Coordinator position has been filled as well. It is being filled by someone from the Ohio Office of EMS and he is due to start on May 10 th . She also spoke about the data projects that can be completed now that we have staff. She also spoke about the transition to NEMSIS data set Version 3 in which 97% of the agencies are now using. Dr. Lindbeck talked about the changes in the Intermediate level certification within National Registry. National Registry

	<p>will no longer certify Intermediates and at some point they will not be in existence. OEM's Training and Certification Committee is in discussions about what to do about this. Will we continue to certify new Intermediates in Virginia? Will we come up with our own testing mechanism? These are a few questions being pondered during this change. The EMSC committee members discussed the specialized skills such as airway management and other topics concerning the Intermediate.</p> <p>Dr. Lindbeck stated that the Office of EMS may want to look at data pertaining to airway interventions for pediatric patients. How many pediatric patients get oxygen therapy alone, how many get nebulizers, and how many get invasive airway of some sort? Dr. Lindbeck stated that they will include pediatric (14 and under) airway management in the ALS/BLS audit over the summer. He will also include pediatric data field such as weight.</p>	<p>Cam will get data regarding airway interventions for pediatric patients.</p>
