Slowly coming back to normal. Objective to get all vaccinations done across the Commonwealth. Talked about the establishment of the Regional Council offices. They are coming online as Hybrid offices with Shenandoah Council being the first Hybrid Council Office (October 2019). Blue Ridge and Fredericksburg are set to become Regional Hybrid Offices (May 2020). Approval to hire more people mainly for the Regional Offices, with some to be hired in the OEMS Office. We are continuing to work towards identifying sites for other offices. Discussed the Bills waiting on approvals. Also, announced that the Advisory Board Meeting will be held on May 7, 2021. The meeting will be held at the Embassy Suites in Richmond beginning at 10:00am.</p> <p>b. Gary Brown 1. Discussed plans for Symposium 2021.
