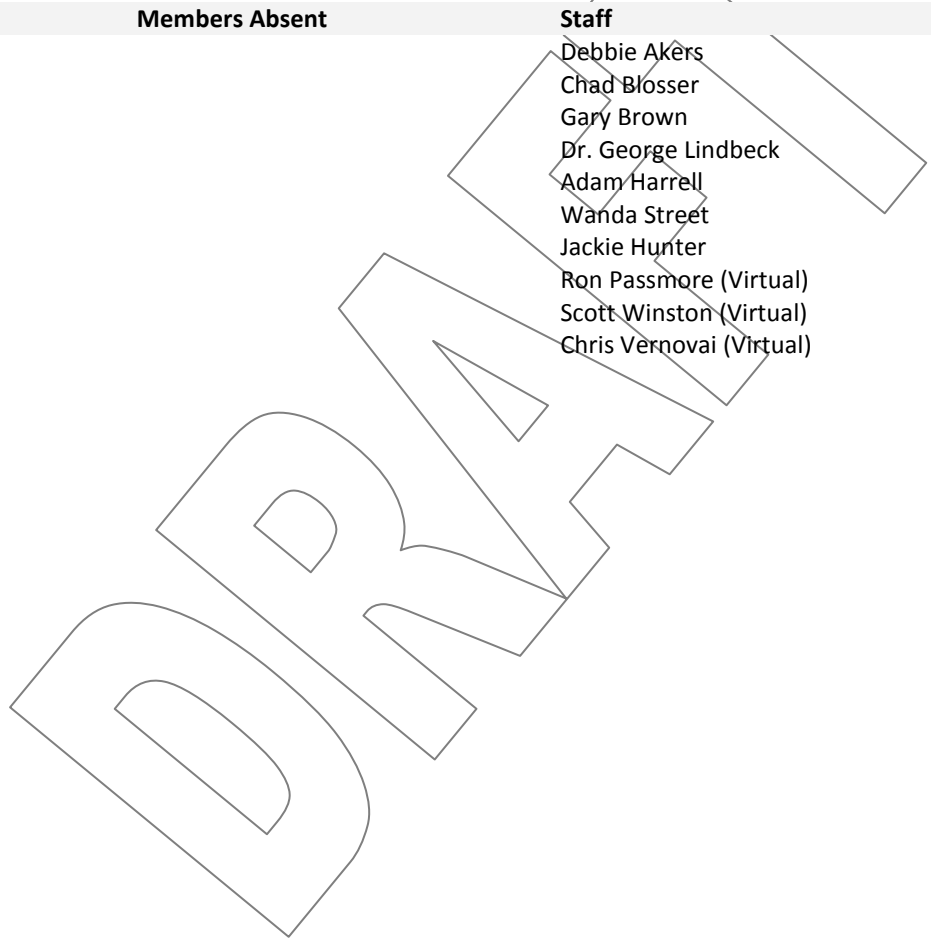

Non-VCCS EMS Program – Steven Moring – Continuing to maintain and follow policies by OEMS and the Governor as it pertains to education.</li> <li>b. VCCS – Bill Akers – General assembly approved G3 Initiative. Chesterfield system office still working on details.</li> <li>c. VAVRS – Bobby Lester – There have been questions about when consolidated testing will restart and working through new computer system issues.</li> <li>d. Regional EMS Council Executive Directors – Craig Evans – Meetings have been held bi-weekly. Have had questions about when consolidated testing will start again and what it will look like in the future.</li> <li>e. EMSC – Vacant – No report.</li> <li>f. VAGEMSA – Larry Oliver – VAGEMSA has met once since the pandemic. This past year has been a challenge for everyone and trying to keep afloat. No specific report.</li> <li>g. Fire Based Organization – Christopher Kroboth – Nothing specific to report.</li> <li>h. Educators – Brian McIntosh – Have been reaching out to education coordinators to address concerns. 	<p>B. Office of EMS</p> <p>1. Division of Accreditation, Certification &amp; Education (ACE)</p> <p>a. Education Program Manager – Chad Blosser, OEMS</p> <ul style="list-style-type: none"> <li>i. Virginia EMS Scholarship Program – In 3<sup>rd</sup> full year, internal preparations to launch 4<sup>th</sup> year. New scholarship year starts June 1. Chad explained the collection process.</li> <li>ii. Education Coordinator Candidate Program – There are 650 certified coordinators and this hasn't changed since last September. Currently there are 306 candidates; 33 fully eligible to attend next Institute as of yesterday; 97 (32%) have not completed any requirements of the program and 250 (81%) have completed some of their teaching hours and have not taken the National Registry exam.</li> <li>iii. Instructor Institute – Completed one in Toano in January 2020 adding 33 educators and one in September 2020 in Norfolk and added 20. An Institute is scheduled early June 2021 at Central Virginia Community College. Deadline is April 23 for Institute eligibility. Planning an Institute in Northern Virginia in late September 2021.</li> <li>iv. The Office will no longer accept any paper forms for processing beginning Jun 1, 2021.</li> <li>v. Educator concerns were discussed which centered on educators not reading, interpreting and following updated guidance information. Educator ethics and morals are declining. They are awarding CE hours falsely, backdating CE hours, failure to enroll students in class, failure to ensure students had CPR prior to class, etc. <ul style="list-style-type: none"> <li>a. Brian suggested getting regional subject matter experts to assist with the first challenge. Debbie welcomes their assistance. Craig will gladly assist. Adam mentioned Zendesk as another option. Chris suggested to “tab” or categorize the TPAM according to subject matter.</li> </ul> </li> </ul> <p>b. ACE Division Director – Debbie Akers, OEMS –</p> <ul style="list-style-type: none"> <li>i. Overview of COVID-19 Administrative Changes since March 2020 – Chad and the committee discussed changes that have occurred since March 2020. National Registry provisional certifications will cease issuance as of July 1, 2021.</li> <li>ii. Virtual Instructor-Led Training (VILT) Program Policies – Dr. Lindbeck discussed the limit of 30 people and that some students have been turned away. <ul style="list-style-type: none"> <li>a. Chad stated that 30 people is a large number to successfully manage virtually. As the Facilitator for OEMS VILT programs, if the class is full at 30, the Facilitator is kept very busy monitoring student participation, launching polls and ensuring student questions get answered.</li> <li>b. Craig stated that we should not control the engagement but have a more compelling instructor.</li> <li>c. Brian suggested to have an instructor-student ratio.</li> </ul> </li> </ul>	<p><b>A workgroup is being formed for VILT.</b></p>

	<p>d. The committee discussed synchronous vs. asynchronous environment and the importance of F5 education. A workgroup will be formed – Steve (chair), Brian (co-chair), Craig.</p> <p>(i.) Debbie will get other VILT instructors to join the workgroup.</p> <p>iii. Prodigy EMS will not be awarded as of April 1, 2021. Cat 2 will be awarded. Discussion about Vector Solutions. OEMS is looking for a replacement for EMSAT and some EMSAT courses will still be available but outdated content will be taken off line.</p> <p>iv. National EMS Education Standards Update – The workgroup is done. It’s in the hands of NHTSA. New standards will be coming out soon. TCC and MDC will need to make decision about patient contact.</p> <p>v. Accreditation – The report was emailed to everyone and Augusta Co. was not included. The updated report is on the website. Due to COVID, no accreditation visits were held. The expiration dates will have to be extended until the end of December.</p> <p>vi. National Registry Pass Rates – The report was emailed. Virginia is 3 percentage points ahead of the national pass rates on first attempt.</p> <p>vii. BLS Certification Testing – Testing is on hold through December 31.</p> <p>2. State Medical Director – Dr. George Lindbeck – Scope of practice document modifications will be looked at tomorrow’s meeting.</p> <p>3. EMS for Children – Dave Edwards, OEMS – He is out on medical leave.</p> <p>4. Regulation &amp; Compliance – Ron Passmore – There has been questions about the House Bill to allow EMT to administer COVID-19 vaccines. There is a clarification document on the OEMS website on this. Jason Ferguson stated that this is another measure at assessing competencies in the accreditation process. Chris stated that this is a good benchmark and check and balance for those that do not go for accreditation.</p>

<b>VIII. New Business</b>	<p>Christopher Kroboth – Over the past 6 months he has received a few phone calls for the best ways to handle new batch of students and entrance exams to help set up groups. He made a recommendation for OEMS to help supplement entrance exams. Chad remembers some discussion years ago about the Hobbit exam. Bill Akers stated that the first question to answer is “What is the goal of administering the exam?” Then look at the best exam for that goal. The best way to start is to come up with a list of options based upon groups per Adam. Find out what the agencies are doing. Jason suggested sending a survey from the Office to the educators on a broad scale. Adam also suggested epidemiologist group and pair them with the consulting firm we just started with and maybe get with an adult educational methodologist outside of EMS. Bring back findings by next meeting or meeting after that.</p> <p>Brian McIntosh – Discussion on extending certifications, mention to Karen Owens about extending to December. Adam will follow up with Karen this afternoon.</p> <p>Jason Ferguson - In your areas, how many are doing a non-credit paramedic program or an accelerated version of paramedic program? Discussion ensued about programs in different areas.</p> <p>Debbie Akers – National Registry is really looking at the future of testing, competency, etc. Debbie is serving on two committees Evidence-Based Guidelines Committee which is reviewing what is considered evidence-based vs. resource material. The other is the Steering Committee looking at psychomotor testing at the EMT level. She will keep everyone updated on this.</p>

## Background

The Virginia EMS Scholarship Program is managed by the Virginia Office of Emergency Medical Services providing scholarship awards to current Virginia EMS Providers and those seeking to become EMS providers in the Commonwealth.

The scholarship program supports students who are accepted into an eligible Virginia approved initial certification program—EMR, EMT, Advanced EMT and Paramedic.

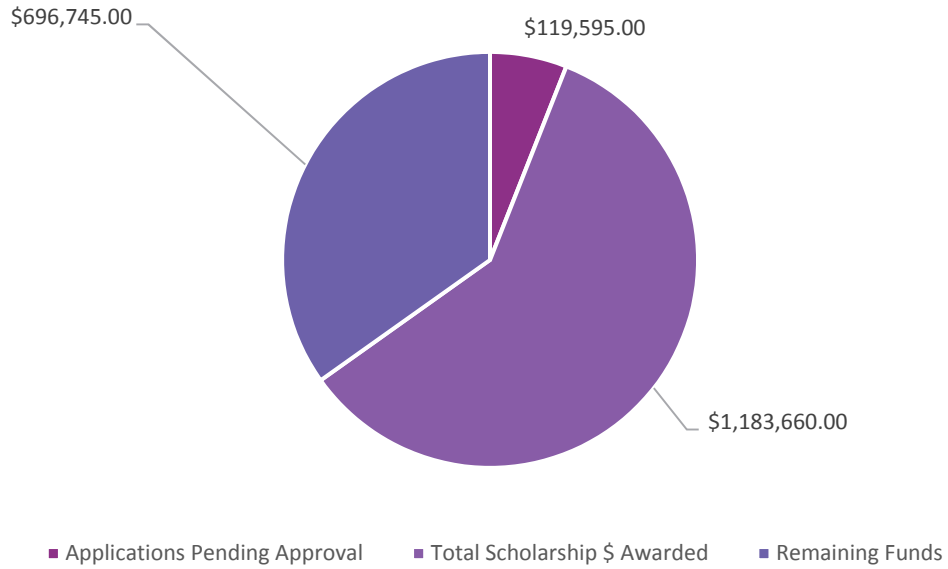
The scholarship program is not designed to provide 100% funding for a training program.

## FY21 Scholarship Budget

The FY20 budget for the Virginia EMS Scholarship Program is \$2,000,000.00. The following chart shows a breakdown of funding based on three (3) categories: 1) Applications Pending Approval, 2) Total Scholarship \$ Awarded, and Remaining Funds.

- **Application Pending Approval** – this category includes the total dollar value for all applications received from June 4, 2021 through March 31, 2020. This covers Q1, Q2, & Q3 of FY20.
- **Total Scholarship \$ Awarded** – this category is the total dollar value for all scholarship applications which have been approved and are in the process of being paid. Since the Virginia EMS Scholarship module is new, OEMS staff have only approved a small group of test applications as we work through the payment processes with the VDH Office of Financial Management.
- **Remaining Funds** – this category is the total dollar value of funds remaining in the scholarship program and available for to students for the remainder of the fiscal year.

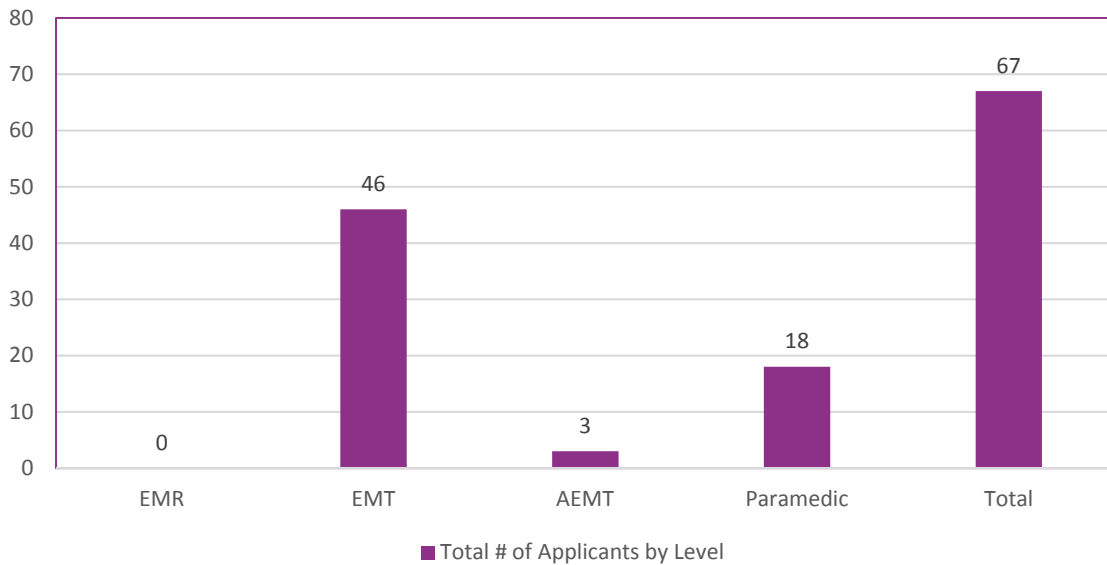
## Scholarship Funding Overview

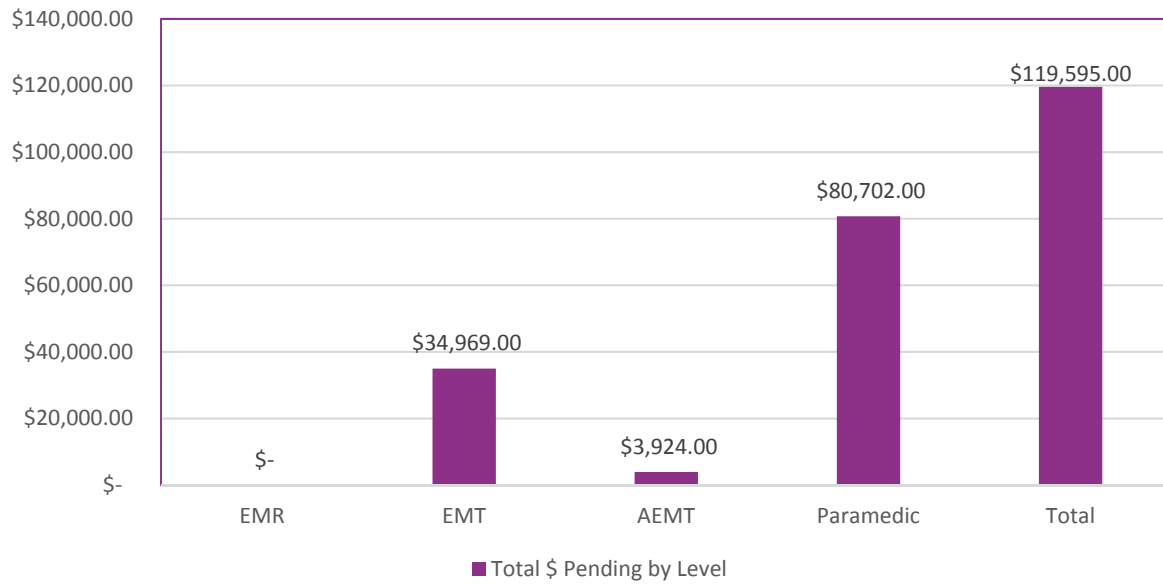

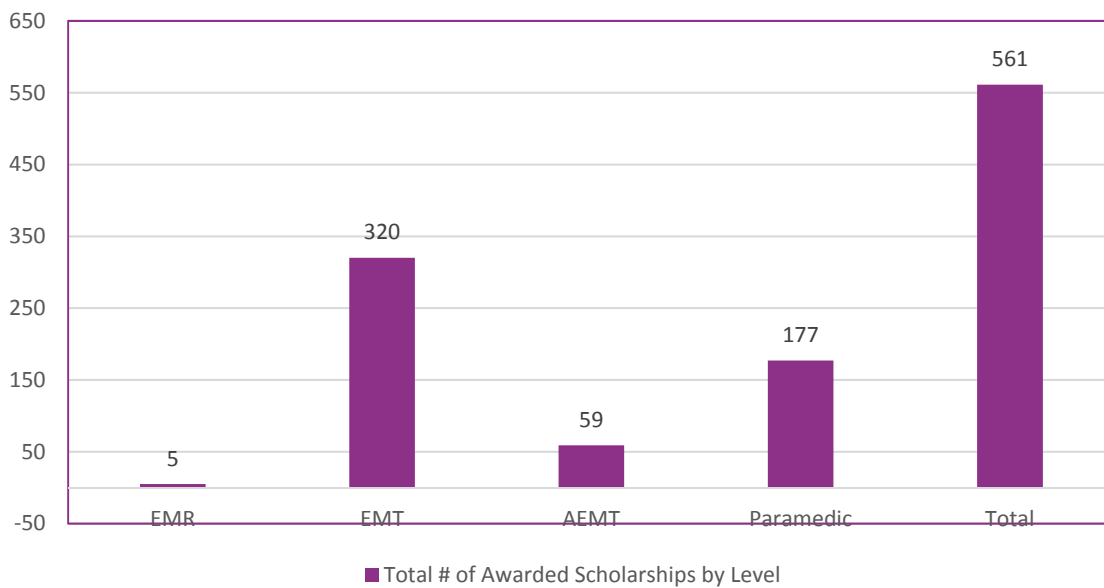
### Total \$ of Pending Applications by Level



## Breakdown of Awarded Scholarships

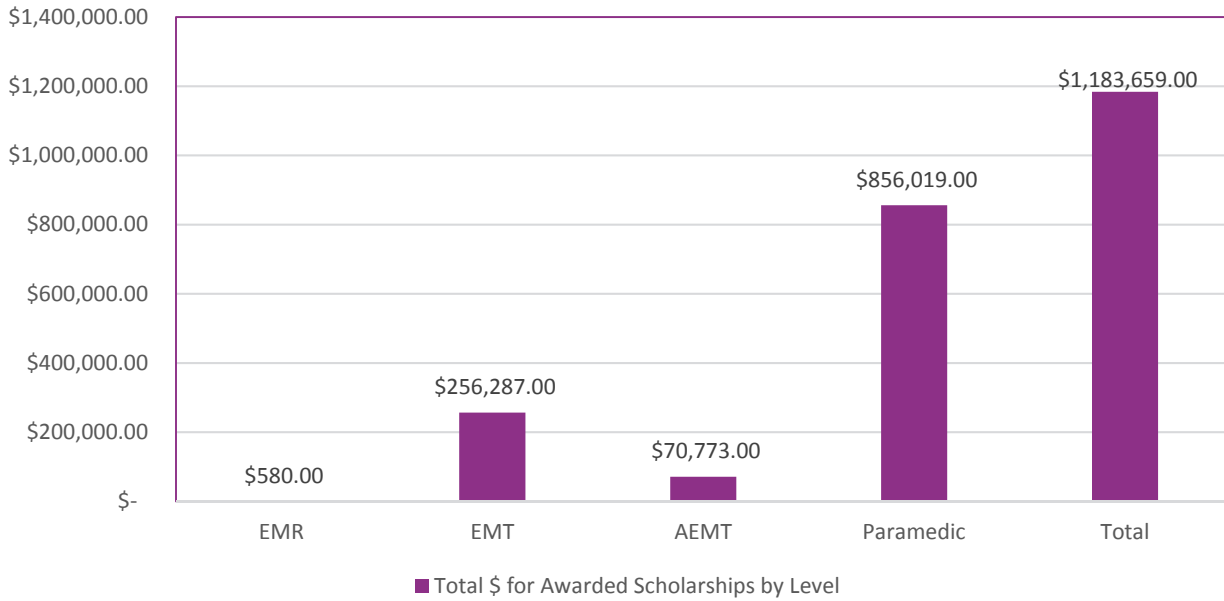

## Accreditation

- A. EMS accreditation programs.

***Due to the COVID-19 pandemic, all BLS and AEMT accredited programs expiring in 2020 will be granted an extension of their accreditation status until December 31, 2021.***

1. Emergency Medical Technician (EMT)
  - a) Arlington County Fire Department continues under Letter of Review pending their accreditation site visit.
  - b) Fauquier County continues under Letter of Review pending their accreditation site visit.
  - c) Hampton Roads Regional EMS Academy continues under Letter of Review pending their accreditation site visit.
  - d) Augusta County continues under Letter of Review pending their accreditation site visit.
  - e) Rockingham County Dept. of Fire and Rescue was issued a Letter of Review allowing their first cohort to occur.
  - f) Gloucester Volunteer Fire and Rescue was issued a Letter of Review allowing their first cohort to occur.



- g) Roanoke Valley Regional Fire/EMS Training Center was issued a Letter of Review allowing their first cohort to occur.

2. EMT Psychomotor Competency Verification Approval

The interest in BLS accreditation continues to grow. We currently have 15 programs that are approved for internal psychomotor competency verification in adherence to the TR-90A policy. Five programs are still approved under the original BLS accreditation process and the Office will be working with them to move them to convert them to psychomotor exempt programs as well.

3. Advanced Emergency Medical Technician (AEMT)

- a) Newport News Fire Training has completed their first cohort class and a site team is being assigned to visit the program and review documentation, meet with graduates of the program and consider the application for full accreditation. They had 17 candidates attempt with a first attempt pass rate of 94% (16/17) and 100% within three attempts.
- b) Fauquier County has completed their first cohort class and a site team is being assigned to visit the program and review documentation, meet with graduates of the program and consider the application for full accreditation. They had 6 candidates attempt with a first attempt pass rate of 83% (5/6).
- c) Rockbridge County has been assigned a Letter of Review to conduct their first cohort class.
- d) Hampton Roads Regional EMS Academy has been assigned a Letter of Review to conduct their first cohort class.
- e) All previously accredited Intermediate programs were transitioned to the Advanced EMT level and will submit a reaccreditation packet for that level.

4. Paramedic – Initial

- a) Blue Ridge Community College has been issued their LOR from CoAEMSP and is enrolling students for their first cohort class.
- b) Thomas Nelson Community College has completed their first cohort class and has submitted their initial report to CoAEMSP.
- c) Henrico County Division of Fire has been issued a LOR from CoAEMSP and will be enrolling students for their first cohort class

## 5. Paramedic – Reaccreditation

- a) CoAEMSP has suspended all reaccreditation visits due to the COVID-19 pandemic and will resume with rescheduling when possible.

- Due to Executive Order 51 & 55, the Virginia Office of EMS will be extending the certification of all providers who are set to expire on May 31, 2020 and have not satisfied their continuing education requirements until August 31, 2020.

### **Virginia Continuing Education**

During the course of any Governor declared State of Emergency the enforcement of regulations, is to not impede, in any way affect, the necessary delivery of services. However, this declaration does not indicate a complete abandonment of the ideal of regulatory compliance; simply to relax the commonsense enforcement of regulations to allow for the needs of citizens to be met.

The Virginia Office of EMS and the National Registry have together extended certification expiration dates for all EMS providers expiring in March, April & May—both state and/or nationally certified—until June 30, 2020. Both organization continue to daily monitor our Nation's progress toward flattening the curve on COVID-19.

Based on the certification extensions granted under Governor Northam's Executive Order 51 and the wide availability of Virginia approved online CE vendors and programs, the following guidance is provided:

- The Virginia Office of EMS will not be relaxing EMS Rules and Regulations or the Training Program Administration Manual (TPAM) policies for conducting, reporting and recordation of continuing education in the Commonwealth.
- Regulations and the Training Program Administration Manual does not permit conducting continuing education online via GoToMeeting, Zoom, Microsoft Teams, Capterra, TeamViewer, Cisco Webex, Skype, Google Hangouts (or any other online/web-based meeting platform) and submit CE credits to Virginia for processing.
- Education Coordinators who transition portions of initial certification programs to online content are not permitted to award CE credits for Virginia EMS providers accessing this content.
- Nationally approved continuing education programs—for example ACLS, PALS, AMLS, PHTLS, PEPP, ITLS, ECP, etc.—that have relaxed their program requirements allowing content to be completed in a modified delivery format have been temporarily approved by the National Registry for continuing education credit and therefore the Office of EMS will also temporarily allow CE to be awarded for Virginia providers completing these

- programs until the Governor’s Executive Orders 51, 53, & 55 are lifted or allowed to expire.

### **Virginia and NREMT Psychomotor Examinations**

- All psychomotor (CTS and NREMT) testing will be suspended, effective Monday, March 16 through June 10, 2020 at a minimum.
- All test deadlines will be extended in accordance with the suspended test sites.

*National Registry Announces Policy Changes Due to COVID-19:*

### **Psychomotor Exams & Provisional Certification**

National Registry will be cancelling all scheduled psychomotor exams by the end of this week and will not be approving any new psychomotor exams for an indefinite period.

NREMT is in the final stages of being able to issue a *provisional* National Registry certification when the following components are completed:

1. Students must complete their certification program according to state or CoAEMSP requirements.
2. Students must sit for and pass the NREMT cognitive exam.
3. When these two items are completed, a 2-year *provisional* certification will be issued. The issued certification will clearly indicate the awarding of provisional certification pending completion of the psychomotor exam when successfully completed.

Provisional certifications can be converted to full certification once the COVID-19 threat is mitigated and the student takes and passes their NREMT required psychomotor exam. States are not required to accept provisional NREMT certifications if they cannot legally do so.

When being scheduled for work, National Registry strongly urges that no two provisionally certified providers work on the same truck. There should always be a fully certified provider riding with a provisionally certified provider.

### **Pearson VUE Owned Professional Test Centers (PPC’s) Closing Due to COVID-19**

On March 16, Pearson VUE notified National Registry that they were closing all Pearson Professional Center’s (PPC) in response to the rapidly developing COVID-19 situation. This decision does not affect privately run Pearson VUE Authorized Test Centers (e.g. those in Regional Councils, community college and universities) This directly impacts all National Registry examinations delivered by Pearson VUE. The National Registry was already preparing alternative pathways, in conjunction with partners, to ensure the continuity of certification and support the national EMS system during this crisis.

These are unprecedented times. NREMT, as the Nation's EMS Certification organization, recognizes the thousands of providers on the path to EMS service. NREMT is finalizing potential solutions and will be sharing additional details in the coming days. We remain committed to supporting the vital work that you do.

Currently, National Registry has been working with Pearson VUE on the following interim solutions:

1. Pearson VUE has opened some PPC's for the health professions ONLY (e.g. EMS and Nursing). Not all existing PPC's will open, maybe just one or two per state.
2. NREMT in the final stages of implementing remote proctoring of NREMT certification exams for EMR, EMT and AEMT test candidates. Remote proctoring through Pearson OnVUE will be a psychometrically sound and legally defensible means of delivering the test in other environments rather than a Pearson Vue Testing Center.
  - a. The only testing candidates required to take their cognitive exam at a Pearson VUE Test Center will be paramedic candidates.

### Education Coordinator Candidate (Mentee) “Teaching Hours”

Based on action the Office took to extend the certification request expiration date for Education Coordinator Candidates (ECC) under Governor Northam’s Executive Order 51, the Virginia Office of EMS has determined that there is not a present need to relax regulatory requirements for the ECC program.

- All ECC required “teaching hours” must be taught in a face-to-face environment and an Education Coordinator above the 16th percentile must be present during the delivery of all content by the candidate.

The FY20 Virginia EMS Scholarship Program will close on May 31, 2020 due to the need to begin the internal processes to close FY20. The FY21 fiscal year for the scholarship program will begin June 1, 2020. These changes should be seamless to the end user of the program.

## Psychomotor Test Site Activity

- A. BLS Psychomotor Testing will be suspended for the duration of 2020 and all programs will be required to follow the TR-999 form developed during the COVID-19 pandemic. This allows the program director and the physician course medical director to determine entry level competency of students. Upon completion of the program, form TR-999 will be submitted to the Virginia Office of EMS and students will have a psychomotor examination generated and submitted to the National Registry.
- B. When meetings resume, the workgroup assigned from Training and Certification will continue their work on designing a more comprehensive psychomotor examination to test entry level competency through critical thinking rather than performance of rote

memorization skills. The Office of EMS is awaiting further direction from National Registry concerning their recommended changes.

## Other Activities

### Student Background Checks through Fieldprint

When the Office negotiated its contract with Fieldprint for provider background checks, we also included an option for EMS Educational Programs to be able to conduct background checks of their student body. All Education Coordinators and accredited EMS Programs may make use of this program at their own discretion. You are not required by this Office to run FBI backgrounds on your EMS students.

If you or your Program Medical Director would like to institute mandatory FBI background checks on your students, they should use the following steps to submit their fingerprints to the FBI. We have attached a flyer for use in your program literature should you decide to implement background checks.

To schedule a fingerprinting appointment as an EMS student, please follow these simple instructions.

1. Visit <http://fieldprintvirginia.com>
2. Click on the “*Schedule an Appointment*” button.
3. Enter an email address under “*New Users/Sign Up*” and click the “*Sign Up*” button. Follow the instructions for creating a Password and Security Question and then click “*Sign Up and Continue*”.
4. Enter the Fieldprint Code **FPVS999NC** when requested.
5. Enter the contact and demographic information required by the FBI and schedule a fingerprint appointment at the location of your choosing.
6. At the end of the process, print the Confirmation Page. Take the Confirmation Page with you to your fingerprint appointment, along with two forms of identification.
7. If you have any questions or problems, contact Katie Hodges ([kathryn.hodges@vdh.virginia.gov](mailto:kathryn.hodges@vdh.virginia.gov)) at the Office of EMS.

Fingerprint results will be submitted to the Office of EMS Division of Regulation and Compliance and a staff member from Regulation and Compliance will notify you as the educator via e-mail the final status of “Eligible” or “Not Eligible” for certification in Virginia.

## **Certification Testing Changes – State and National Registry**

### **BLS Certification Testing**

- **Cognitive Exams** – The National Registry has implemented cognitive examination testing through the Pearson OnVUE Testing process which allows remotely proctored cognitive exams to be completed in locations such as their home provided they can meet the security requirements. This process became available on May, 12, 2020.

- **Psychomotor Exams** – After careful consideration, the Office of EMS Management Team has decided to cancel all further Consolidated Testing at the BLS level through December 31, 2020 due to Executive Order 51, 53 & 55. With so many unknown factors in the months ahead and the amount of advanced planning and commitment required to hold a CTS, we determined cancellation to be in the best interest of the health, safety and well-being of all participants. Students will receive guidance from their Course Coordinator as to how their psychomotor skills will be tested in lieu of Consolidated Testing.

### **ALS Certification Testing**

## National Registry

- **National Registry & Virginia Provisional Certifications – (Advanced EMT and Paramedic ONLY!)**
  - National Registry & Virginia have restarted the process of scheduling NREMT psychomotor exams.
  - For those who were not able to take their NREMT psychomotor exam due to the COVID-19 pandemic, the Board of the National Registry has approved the issuance of a provisional certification. In Virginia, this will only impact the Advanced EMT and Paramedic certification levels. A provisional National Registry certification is issued when a student:
    1. completes their certification program according to state or CoAEMSP requirements, and
    2. sits for and passes the National Registry cognitive exam.

3. When these items are completed, a provisional National Registry certification will be issued with an expiration date of December 31, 2021. The issued certification will clearly indicate the awarding of provisional certification pending completion of the psychomotor exam when successfully completed.
- Provisional certifications can be converted to full certification once the COVID-19 threat is mitigated and the student takes and passes their NREMT required psychomotor exam.
  - Virginia has begun accepting and likewise issuing provisional certification cards when the National Registry transmits these results to us. Please see the [sample provisional Virginia certification card](#). We are providing this sample to you so that you are aware of what we will be issuing during the COVID-19 pandemic. The sample is highlighted to indicate the changes that will be made to certification cards issued under this provisional authority.
  - The issuance of a provisional certification by the Virginia Office of EMS is not reflective that the Office is restricting provider practice. The ability for a provider to practice is solely up to the EMS Agency and the agency's Operational Medical Director. We are issuing provisional certifications as a means of ensuring that we have a mechanism to track these providers and ensure that they complete their certification process once the COVID-19 threat is mitigated.
  - When being scheduled for work, National Registry strongly urges that no two provisionally certified providers work on the same truck. There should always be a fully certified provider riding with a provisionally certified provider.
  - Should a provider who was granted provisional Virginia certification based off of a National Registry provisional certification not fulfill the requirements of their National Registry certification, the Office of EMS will initiate the process of revocation of the provider's certification in the Commonwealth.

### **National Registry Cognitive Examinations**

## Certification Cards No Longer Required for EMS Agency Inspection Requirements

### **Extension of Certification Expirations**

No further extension of certifications has been granted or are anticipated at this time. All providers must meet their continuing education requirements by the last day of their certification expiration month, or the provider will go into reentry per our normal regulatory requirements.

### **TPAM Policy T-1445 – Course Scheduling**

As a reminder, in the May 2020 update to the Training Program Administration Manual, we made it possible for Cardiopulmonary Resuscitation (CPR) to be a pre or co-requisite for initial certification programs. If CPR is offered as a co-requisite, the student must obtain a valid CPR card by the end date of the course as announced to the Office. Failure to obtain CPR by the end date of the course or marking a student as “Pass” for the course without a valid CPR card is not permitted and will be considered a violation of this policy.

### **Field and Clinical Requirements for EMT and Advanced EMT Programs (T-1445)**

State and regional Medical Directors have reiterated, as late as August 12, 2020, the importance of students in initial certification programs successfully completing and meeting all field and clinical requirements as specified for all certification programs. Educators and Program Directors conducting initial certification programs during COVID-19 are expected to seek out all possibilities to ensure students are able to meet all field and clinical requirements until at least June 30, 2021. If an educator or Program Director has exhausted all possibilities for field and clinical sites for their students and they are unable to secure sites due to COVID-19 limitations or restrictions, then the educator or Program Director shall:

1. Secure an attestation statement from each site indicating that they will not allow access to their facility for your students due to COVID-19 limitations or restrictions.
  - a. The attestation statement must include signatures (physical or electronic) from the educator, the field or clinical site representative and the program Medical Director.
  - b. A sample attestation statement is attached.
2. Once attestation statements have been received for all sites, the educator or Program Director can then allow field and/or clinical competencies to be conducted with the students using programmed patients and/or advanced simulation scenarios until you are comfortable that the student is satisfactorily competent.
  - a. Field and/or clinical competency stations should limit the number of people in contact with one another in compliance with social distancing guidelines.

- b. Screening of all students and staff is required before ANY in-person meetings with them using form TR-900 – Student Screening Log. Maintain the screening log along with TR-06 – Course Roster.
  - c. Maintain social distancing requirements of six (6) feet of separation to the best of your ability.
  - d. ANY face-to-face field and/or clinical competency stations sessions that require being less than six (6) feet apart shall use adequate PPE to ensure all involved are protected to the highest degree possible.
3. Attestation statements are required to be maintained by the educator with their course files.

### **BLS Certification Testing**

- Cognitive Exams – The National Registry has implemented cognitive examination testing through the Pearson OnVUE Testing process which allows remotely proctored cognitive exams to be completed in locations such as their home provided they can meet the security requirements. This process became available on May, 12, 2020.

  - Pearson OnVUE remote proctoring will be temporary, however the National Registry is planning to implement a more permanent remote proctoring solution in 2021.
  - Once a candidate sits for and passes the National Registry Cognitive Exam, they will be issued a full National Registry and Virginia certification.
- Psychomotor Exams – After careful consideration, the Office of EMS Management Team has decided to cancel all further Consolidated Testing at the BLS level through June 30, 2021 due to the COVID-19 pandemic. With so many unknown factors in the months ahead and the amount of advanced planning and commitment required to hold a CTS, we determined cancellation to be in the best interest of the health, safety and well-being of all participants. Students will receive guidance from their Course Coordinator as to how their psychomotor skills will be tested in lieu of Consolidated Testing.

### National Registry

- **National Registry & Virginia Provisional Certifications – (Advanced EMT and Paramedic ONLY!)**
  - National Registry will cease issuing provisional certifications on December 31, 2020.
  - National Registry & Virginia have restarted the process of scheduling NREMT psychomotor exams.
  - For those who were not able to take their NREMT psychomotor exam due to the COVID-19 pandemic, the Board of the National Registry has approved the issuance of a provisional certification. In Virginia, this will only impact the Advanced EMT and Paramedic certification levels. A provisional National Registry certification is issued when a student:
    1. completes their certification program according to state or CoAEMSP requirements, and
    2. sits for and passes the National Registry cognitive exam.
    3. When these items are completed, a provisional National Registry certification will be issued with an expiration date of December 31, 2021. The issued certification will clearly indicate the awarding of provisional certification pending completion of the psychomotor exam when successfully completed.
  - Provisional certifications can be converted to full certification once the COVID-19 threat is mitigated and the student takes and passes their NREMT required psychomotor exam.
  - Virginia has begun accepting and likewise issuing provisional certifications cards when the National Registry transmits these results to us. Please see the [sample provisional Virginia certification card](#). We are providing this sample to you so that you are aware of what we will be issuing during the COVID-19 pandemic. The sample is highlighted to indicate the changes that will be made to certification cards issued under this provisional authority.
  - The issuance of a provisional certification by the Virginia Office of EMS is not reflective that the Office is restricting provider practice. The ability for a provider to practice is solely up to the EMS Agency and the agency's Operational Medical Director. We are issuing provisional certifications as a means of ensuring that we have a mechanism to track these providers and ensure that they complete their certification process once the COVID-19 threat is mitigated.
  - When being scheduled for work, National Registry strongly urges that no two provisionally certified providers work on the same truck. There should always be a fully certified provider riding with a provisionally certified provider.
  - Should a provider who was granted provisional Virginia certification based off of a National Registry provisional certification not fulfill the requirements of their National Registry certification, the Office of EMS will initiate the process of revocation of the provider's certification in the Commonwealth.

## General Updates

### Virginia Course Approval Requests

Another long promised enhancement to the Virginia EMS Portal is finally here. Today we are introducing online submission of EMS Course Requests through the Virginia EMS Portal. Beginning Tuesday, October 27, 2020, the Office of EMS no longer accepts electronic or paper submissions of form TR-01 – Course Approval Request. Any paper or electronic forms received from October 27, 2020 forward will be returned to the Education Coordinator / ALS-Coordinator and they will be asked to login to the Virginia EMS Portal to complete their submissions.

The Course Request feature is fully integrated into the Virginia EMS Portal and involves several approval flows/queues for your courses. At any step in the process, it is possible for your EMS Physician or the Office of EMS to deny a course request. You will be notified of the decision of your EMS Physician and/or the Office of EMS via e-mail messages from the EMS Portal.

For most courses, you will need only select the course type and fill in the requisite details and click submit for approval. However, there are occasions when you must submit an attachment as a part of your course approval:

1. All Auxiliary Courses will require that you submit a digital copy of your instructor certification from the parent organization for that program. You will not be able to complete the submission process without an attachment. Attachments can be in the form of: PDF, DOCX, JPG, PNG, TIF.
2. All “custom CE” courses will require that you submit form [TR-19 - Custom CE Program Outline](#) (attached). You will not be able to complete the submission process without an attachment.
3. All “VILT” courses will require that you submit form [TR-18 - VILT Program Course Schedule and Registration](#) (attached). You will not be able to complete the submission process without an attachment.

### Digital Certification Cards

Digital certificates make keeping your certification with you easier than ever. The certificates are easy to pull up from a cell phone or computer. Digital certificates also make it a snap for an employer or organization to check and verify your certification levels.

Accessing a digital version of your certification card is as easy as logging into the Virginia EMS Portal. A fact sheet on digital certification cards is attached to this message. Providers can now download their certification card directly to their devices and keep it with them in digital format wherever they go!

#### Why transition to digital certification?

1. EMS providers lose their certification cards, frequently. With digital certification cards providers never have to worry about replacement cards because providers will always have access to the digital certification for the duration of their certification period.
2. Saving taxpayer money! Certification card stock, the cost of envelopes and postage, manpower to print, fold and stuff cards all cost money! Money which could be better spent on new technology resources, increased funding for the Rescue Squad Assistance Fund, and other benefits to the EMS system as a whole.
3. Instead of faxing or mailing copies of your certification card to your employer or anyone requesting proof of your training, just e-mail them your Virginia EMS Certification card. It's fast and easy!
4. Be on the cutting edge and go green! Save our valuable natural resources whenever possible.

#### Concerned about Safety and Security?

Verify any Virginia EMS certification quickly on the Office of EMS website. This website allows for a search by a certificate number, first and last name and/or agency. If you are an employer and your employee has given you his or her Virginia EMS certification, or even just the certification number, you can use it to search for the certificate to validate that it's valid as well as see when it expires.

## Virginia EMS Portal Two-Factor Authentication

Late last week, our IT Team put into production an upgrade for the two-factor authentication used to verify an individual's identity and allow for on-the-fly password changes.

By default, two-factor authentication now uses SMS to send a 6-digit authentication token to the user's cellphone which must be entered before the EMS Portal allows a password to be reset. The addition of this new method for two-factor authentication is a much needed enhancement to our security and the ability for end-users to make password resets without the need to call or e-mail the OEMS Help Desk.

## Virginia CE Requirements

As of today (October 1, 2020), very few providers will be left on the 2012 CE recertification cycle. Therefore, we released an update recertification worksheet which combines BLS and ALS CE hours together on one easy-to-read page.

**Executive Order 72 - Common Sense Surge Restrictions Certain Temporary Restrictions Due To Novel Coronavirus**

This announcement has caused a number of you to reach out for further guidance. A full reading of the Executive Order 72 Section B1 – Other Restrictions explicitly indicates “...*the presence of more than 10 individuals performing functions of their employment or assembled in an educational instructional setting is not a “gathering.”*”



Based upon a full reading of the Executive Order 72, the Office has determined that there is no reason to change the number of students who can be present for EMS education programs to include initial and continuing education courses, however the **following guidance is now MANDATORY** for all classes being held from December 14, 2020 through January 31, 2021 unless and until other changes are adopted by the Governor.

- Everyone shall wear a face covering or face mask at all times while indoors.
- Everyone shall maintain 6ft social distancing at all times and throughout the class:
  - This means no small group gatherings to “catch up”
  - Please do not permit “gathering” or “hanging around” in main travel corridors in order to limit exposure.
- No handshaking, hugging or other physical contact.
- All Educators shall conduct Health Screenings at the start of your class in order to assist with Contact Tracing, should it be necessary. The use of forms [TR-900-INST – Student Screening Guidance Instructions](#) and [TR-900 – Student Screening Log](#) is required.

### **Prodigy Refresh 2021**

Refresh 2021 is an opportunity to do something nice for the EMS profession during what has otherwise been a distressing and disorienting year for our profession.

Refresh 2021 will provide 30 hours of CAPCE accredited education that will be accepted by NREMT. Because of the waiver on limits to Distributive Education (DE) during the pandemic the course can be used to satisfy the National hours for EMT or Paramedic recertification. Any additional hours can be used to satisfy the Individual training hour requirements.

There is no catch, the NCCR is completely free. After you complete all of the modules you will receive 30 CAPCE F3 (distributive) hours for you to use towards your recertification. This training is designed to meet the entire NCCR for all level of providers. For EMRs, EMTs, and AEMTs you can use the remaining hours towards your local or individual.

The Virginia Office of EMS is working with Prodigy to have continuing education completions for Virginia EMS providers submitted to the Office for processing and application to CE Reports.

The transfer of data will be manual, so CE credits will not immediately show up on your CE Report.

## 16th Percentile Peer-to-Peer Benchmarking

The Office just published the *16th Percentile Peer-to-Peer Benchmarking* for January 2021. The *16th Percentile Peer-to-Peer Benchmark* is used by the Office of EMS to compare Education Coordinators conducting like programs in contrast to one another.

This tool is used to by the Office of EMS to determine which programs are eligible for funding through the Virginia EMS Scholarship Program and to determine which Education Coordinators in the Commonwealth can serve as mentors for the Education Coordinator certification program.

Note: We did not update the *16th Percentile Peer-to-Peer Benchmark* data last July due to issues with courses that were delayed in finishing due to the declared COVID-19 pandemic.

## REGULATORY REMINDER: 12VAC5-31-1439. Verification of student course completion.

This is a reminder to educators that **all students must be provided a disposition upon course end date** having been reached.

- BLS students must complete all requirements within 180 days of the announced course end date or they will forfeit their opportunity to test from that program.
- ALS students have 180 days or must be enrolled in a new course to continue their path toward certification.

## National Registry

### National Registry Certification Applications

Educators **should not be approving** a second application for students who failed their first attempt at the NREMT Cognitive Exam. Students who failed their first attempt need to click “Express Application” to continue their testing attempts.

By approving new applications for certification testing, Educators are authorizing the Virginia Office of EMS to pay for a second, third, etc. attempt at the exam, which is a violation of established policy.

### National Registry Website

The National Registry just updated their website. It looks and functions very differently from the past version. If you had bookmarks to various pages on [www.nremt.org](http://www.nremt.org), you may want to take some time to familiarize yourself with the new site and update those book marks so you are not struggling to locate information you need at the last minute.

## **NREMT Provisional Certifications**

Provisional certifications extended to June 30, 2021 by the National Registry but all provisional certificates will expire on December 31, 2021.

### *Important Information*

- National Registry Provisional Certifications will continue to be issued until June 30, 2021.
- Provisional Certification will be automatically assigned to any candidate that;
  - Completes an educational program at the EMR, EMT, AEMT or Paramedic level, and
  - Successfully passes the National Registry's cognitive (computer-based) examination.
- Provisional certification is a National Registry certification but is not the same as being fully Nationally Registered.
- The path to convert a provisional certification to full Nationally Registry certification only requires successful completion of the psychomotor examination.
- Provisional Certifications will remain valid through the end of next year – December 31, 2021; or until an EMS provider passes the psychomotor examination before the expiration date.
- Please check with your State EMS Office for state rules on using provisional certifications for licensure or authorization to practice.

### *VERY Important Information*

- All National Registry provisionally certified candidates have until December 31, 2021; or until an EMS provider passes the psychomotor examination before the expiration date.
- ANY PROVIDER with a National Registry and Virginia provisional certification should begin planning now to schedule and complete their NREMT psychomotor examination in order to convert their provisional certification to a full certification.
- Any Virginia EMS provider with a provisional certification as of January 1, 2023 will be reported to the Division of Regulation & Compliance and their provisional certification will be revoked immediately for failing to follow through with established NREMT and OEMS policies.

## **National Registry & OEMS Data Exchange**

The National Registry is currently experiencing an issue with the processing of the BLS psychomotor results forwarded to them by Virginia after the students have been marked as passed in the CSDR. Their IT team is working on a resolution but testing candidates will likely receive a provisional certification from the National Registry.

***PLEASE NOTE:*** Virginia does not issue provisional certifications for EMR and EMT candidates. Full certification will be issued by Virginia and their full NR certification will be issued when the current IT situation is resolved.

## National Registry Recert 2.0 for 2021

As a reminder, please have providers use the [Guide to Completing National Registry Recertification 2.0 Application](#) when completing their NR recertification and to choose the 'Recertify Me' option in their Virginia EMS Portal after being notified of their NR recertification in order to keep their Virginia and National Registry certifications in sync.

## National Registry Audits

The National Registry will be contacting Debbie Akers for any provider who has been selected for audit. If the CE reports are not aligned, Debbie will not be able to verify their recertification eligibility and they will need to be prepared to produce the documentation for National Registry.

This is one of the key benefits to making use of the [Guide to Completing National Registry Recertification 2.0 Application](#) which has been developed by OEMS and approved by National Registry to assist Virginia providers who are certified with National Registry to complete their recertification application based on the National Continued Competency Program (NCCP).

## National Registry Cognitive Examinations

- NREMT currently offers two different options for taking the cognitive exams: face-to-face exams at a Pearson VUE Testing Center and remotely proctored exams making use of Pearson OnVUE.
  - Candidates, when applying for their cognitive exam have the opportunity to select whether they would like to take their exam face-to-face exams at a Pearson VUE Testing Center or a remotely proctored exam on Pearson OnVUE.

### Virginia Course Approval Requests

Another long promised enhancement to the Virginia EMS Portal is finally here. Today we are introducing online submission of EMS Course Requests through the Virginia EMS Portal. Beginning Tuesday, October 27, 2020, the Office of EMS no longer accepts electronic or paper submissions of form TR-01 – Course Approval Request. Any paper or electronic forms

received from October 27, 2020 forward will be returned to the Education Coordinator / ALS-Coordinator and they will be asked to login to the Virginia EMS Portal to complete their submissions.

## **Digital Certification Cards**

The Office of EMS introduce digital certification cards to EMS providers, EMS Physicians and EMS Agency Leadership in late October.

Digital certificates make keeping your certification with you easier than ever. The certificates are easy to pull up from a cell phone or computer. Digital certificates also make it a snap for an employer or organization to check and verify your certification levels.

Accessing a digital version of your certification card is as easy as logging into the Virginia EMS Portal. A fact sheet on digital certification cards is attached to this message. Providers can now download their certification card directly to their devices and keep it with them in digital format wherever they go!

### Why transition to digital certification?

1. EMS providers lose their certification cards, frequently. With digital certification cards providers never have to worry about replacement cards because providers will always have access to the digital certification for the duration of their certification period.
2. Saving taxpayer money! Certification card stock, the cost of envelopes and postage, manpower to print, fold and stuff cards all cost money! Money which could be better spent on new technology resources, increased funding for the Rescue Squad Assistance Fund, and other benefits to the EMS system as a whole.
3. Instead of faxing or mailing copies of your certification card to your employer or anyone requesting proof of your training, just e-mail them your Virginia EMS Certification card. It's fast and easy!
4. Be on the cutting edge and go green! Save our valuable natural resources whenever possible.

### Concerned about Safety and Security?

Verify any Virginia EMS certification quickly on the Office of EMS website. This website allows for a search by a certificate number, first and last name and/or agency. If you are an employer and your employee has given you his or her Virginia EMS certification, or even just the certification number, you can use it to search for the certificate to validate that it's valid as well as see when it expires.

This tool makes compliance and HR record keeping a breeze. Just go to the Virginia Office of EMS Digital Certification Verification web page and search for the certificate number you are trying to verify.

# Digital Certification Card Fact Sheet<sup>1</sup>

A Virginia Office of Emergency Medical Services (heretofore referred to as the Virginia Office of EMS) digital certification card (sample attached) is the electronic form of a Virginia Office of EMS printed certification card. “Digital” is defined as “composed of data in the form of especially binary digits. E.g. “digital images”.<sup>2</sup> The term “certification” means verification that on the indicated completion date the participant named on the Virginia Office of EMS certification card demonstrated achievement of the required knowledge and hands-on skill performance objectives to the satisfaction of a qualified and currently authorized Virginia Office of EMS provider. Certification (or recertification) in a Virginia Office of EMS training program is documented by the legitimate issuance of a correctly completed Virginia Office of EMS print or digital certification card.

Virginia Office of EMS does not offer or endorse online-only initial emergency medical services certification training programs. Virginia Office of EMS training is competency-based and certification requires evaluation and verification of a participant’s cognitive and psychomotor skills as required by the National Registry of EMT’s. Online-only initial EMS certification training does not meet the standards of the Virginia Department of Health Office of Emergency Medical Services or the National Registry of EMT’s.

## Relevant Facts Concerning Electronic Records

1. The Federal Occupational Safety and Health Administration (OSHA) have permitted electronic recordkeeping of employee safety training records since 1997.<sup>3</sup>
2. Just as with paper documents, electronic documents are a record. Regarding its own records management program, OSHA has stated “*The electronic data may be considered a copy of a hard copy or paper record. If a hard copy or paper record is not maintained, then the electronic copy is the record copy*”.<sup>4</sup>
3. Since 2001 U.S. Federal courts have accepted electronic records (legal filings) over the Internet via the Public Access to Court Electronic Records ([PACER](#)) system.
4. Amendments to the Federal Rules of Civil Procedure require civil litigants to preserve and produce any electronically stored information as it can play an important role as evidence.<sup>5</sup> There is no doubt that electronic records have the same legal force as those produced in other formats (such as paper).
5. U.S. Food and Drug Administration (FDA) regulations permit electronic records and electronic signatures as equivalent to paper records and handwritten signatures executed on paper. FDA regulations are intended to permit the widest possible use of electronic technology, compatible with FDA’s responsibility to protect the public health.<sup>6</sup>
6. Web content is rendered in two basic forms - dynamic and static. Dynamic web content consists of information that is rendered differently based on specific user input and is managed in a database associated with a server. Static content consists of information in the form of documents that are rendered identically each time they are accessed. Both static and dynamic web content are considered a permanent record and meet the requirements of the U.S. National Archives and Records Administration (NARA) Electronic Records Management (ERM) E-Gov Initiative.<sup>7</sup>
  - a. Virginia Office of EMS Digital Certification Cards are both static and dynamic. Each document is rendered identically in static format (PDF) and is based on the providers dynamic certification records in the Virginia EMS Portal.
  - b. Every Digital Certification Card is a true and accurate record of the original information received by the Virginia Office of EMS on the date the record was downloaded and is uniquely tracked in the Virginia EMS Portal electronic content managementsystem.

7. The United States Federal Government Paperwork Elimination Act (GPEA) uses *reliability, authenticity, integrity, and usability* to describe the characteristics of trustworthy records.<sup>8</sup> The Virginia Office of EMS follows best practice guidelines regarding reliability, authenticity, integrity, and usability. Consequently, a Virginia Office of EMS Digital Certification Card(s):
- a. *Reliably* identifies the certified Virginia Office of EMS Education Coordinator and the National Registry of EMT's as the record source and provides evidence that the Virginia Office of EMS certified Education Coordinator documented achievement of the participant's knowledge in cognitive and psychomotor performance according to the program standard.
  - b. *Authentically* establishes what it purports to be. The Virginia Office of EMS business practices and electronic content management system controls the creation, transmission, receipt, and maintenance of the Digital Certification Card. The transaction is tied electronically to the Virginia Office of EMS Portal.
  - c. *Integrity* is supported by Virginia Office of EMS rules and regulations, standards, business practices, and electronic content management system that prohibit alteration.
  - d. *Usability* ensures that it can be located, retrieved, presented, and directly connected to the provider's certification records and certified Education Coordinator who coordinated the program. The link to the Digital Certification Card remains permanently active.
