The meeting was called to order by Ashleigh Greenwood at 9:00am. A review of the agenda was presented and approved. Minutes of the December 4, 2020 meeting were approved.

Implementation of CMV in Virginia:

CVM testing started on September 1, 2020. The cost of the testing is approximately \$60 and is spread across all of the collection places. This equals out to about \$2 per baby.

The testing platform is FDA cleared assay. Collection is a saliva swab that needs to be kept cold and should be done 1 hour after breastfeeding.

- 65,183 cCMV screenings completed from 9/1/20 5/19/21.
- 1907 cCMV screens submitted
- 52 positive
- 37 passed
- 34 false positives
- 4 diagnosed with SNHL
- 2 diagnosed with other hearing loss
- 2 inconclusive
- 137 rejected

CMV Discussion:

An open Q&A session was held where participants had the opportunity to discuss the implementation of cCMV screening in Virginia and ask the Panel members questions. Questions included specifics on how PCP's are provided cCMV results, when PCPs would be able to access results from the Virginia Infant Screening Infant Tracking System (VISITS) directly, and who the best point of contact would be for questions for PCPs. Additional discussion points addressed the testing parameters and false positivity rates.

Parent Laura Sullivan voiced a concerned. The cCMV process did not go well for her family. Beginning with the cheek swab she was not told her baby should be fed an hour before the screening. Mrs. Sullivan felt better communication was needed. She felt she was not given enough information. She received 2 phone calls saying her baby's screen was negative but it was not, it was positive, and she felt robbed of 10 days because of this. Dr. Levorson was the only person who gave her good information.

COVID Needs Assessment:
