Regarding File Number 2012-02606, Harlowe-Powell Auction, Ltd., Board members reviewed the Consent Order as seen and agreed to by Harlowe-Powell Auction, Ltd. Mr. Linkous moved to accept the Consent Order which cites the following violation of the Board's regulations: 18VAC25-21-110 (Count 1). For this violation, Harlowe-Powell Auction. Ltd. agrees to the following sanctions: \$1,000.00 for the violation contained in Count 1; and \$150.00 in Board costs, for a total monetary penalty of \$1,150.00. In addition, Mr. Norman Dill, on behalf of Harlowe-Powell Auction, Ltd., agrees to complete six (6) hours of Boardapproved continuing education. The continuing education hours will not count towards any hours required for renewal or reinstatement. Ms. Wang seconded the motion which was unanimously approved by members: Bryant, Daniel, Linkous and Wang.

Regarding File Number 2012-02722, Richard G. Graves, Board members reviewed the Consent Order as seen and agreed to by Mr. Graves. Mr. Linkous moved to accept the Consent Order which cites the following violation of the Board's regulations: 18VAC25-21-110.A (Count 1). For this violation, Mr. Graves agrees to the following sanctions: \$500.00 for the violation contained in Count 1; and \$150.00 in Board costs, for a total monetary penalty of \$650.00. Ms. Wang seconded the motion which was unanimously approved by members: Bryant, Linkous and Wang. As the reviewing Board member Mr. Daniel was not present for the discussion or vote.

Ms. Brooks provided details on the Governor's Regulatory Reform Regulatory Update Initiative, explaining that the public comment period was an opportunity for feedback on any regulations that are thought unnecessary or burdensome. The public comment period ended December 5, 2012, the Board did not receive any comments. Additionally, staff had no recommendations at this time.

Ms. Brooks reminded the Board that the Governor's review of the proposed regulations was completed September 11, 2012, and the regulations were not approved. She further reminded the Board that at its October 10, 2012, meeting, the Board voted to remove regulation 18VAC25-21-95.B was removed, in order to refile the proposed The documents were amended and submitted to the regulations. Board members were provided a comprehensive report of enforcement activity for informational purposes.
