This regulatory action (i) re-codifies the "Emission Standards for Open Burning" as the "Regulation for Open Burning" in 9 VAC 5 Chapter130; and (ii) deletes the existing "Open Burning Rule" (Rule 4-40) located in Article 40, 9 VAC 5 Chapter 40.

### Statement of Final Agency Action

On December 15, 2008, the State Air Pollution Control Board took final action to adopt the regulation entitled "Regulation for Open Burning" (9 VAC 5 Chapter 130). The regulatory action is to be effective as provided in the Administrative Process Act.

The regulation amendments are exempt from the state administrative procedures for adoption of regulations contained in Article 2 of the Administrative Process Act by the provisions of § 2.2-4006 A 3 of the Administrative Process Act because they consist only of changes in style or form or corrections of technical errors.

In adopting these amendments, the Board affirmed that it will receive, consider and respond to petitions by any person at any time with respect to reconsideration or revision, as provided in § 2.2-4006 B of the Administrative Process Act.

Section 10.1-1308 of the Virginia Air Pollution Control Law (Title 10.1, Chapter 13 of the Code of Virginia) authorizes the State Air Pollution Control Board to promulgate regulations abating, controlling and prohibiting air pollution in order to protect public health and welfare. Letters providing written assurance from the Office of the Attorney General that (i) the Board has statutory authority to promulgate the final regulation amendments and (ii) the amendments qualify as an exemption under § 2.2-4006 A 3 of the Administrative Process Act are available upon request.

## Family Impact
