## Notice of Intended Regulatory Action (NOIRA) Agency Background Document

In response to the Governor's Regulatory Reform initiative, the Board for Asbestos, Lead, and Home Inspectors seeks to review and amend its current regulations to repeal regulations that are unnecessary or no longer in use and reduce unnecessary regulatory burdens on regulated groups.

§ 54.1-201.5 of the *Code of Virginia* (<http://leg1.state.va.us/cgi-bin/legp504.exe?000+cod+54.1-201>) states that the Board has the power and duty "To promulgate regulations in accordance with the Administrative Process Act (§ [2.2-4000](#) et seq.) necessary to assure continued competency, to prevent

deceptive or misleading practices by practitioners and to effectively administer the regulatory system administered by the regulatory board.”

§ 54.1-501 of the *Code of Virginia* (<http://leg1.state.va.us/cgi-bin/legp504.exe?000+cod+54.1-501>) provides the authority for the Board to promulgate regulations for the licensure of lead professionals and firms, approval of accredited lead training programs, and approval of criteria for accredited lead training programs. The content of the regulations is pursuant to the Board’s discretion, but shall not be in conflict with the purposes of the statutory authority.

The proposed amendments will focus solely on a general but comprehensive review of the existing regulations. The review will amend the regulations to eliminate burdensome entry requirements while continuing to effectively protect the health, safety, and welfare of the public.

The proposed amendment will amend 18VAC15-30-167.B to allow a licensee or an accredited lead training provider to renew a license or accredited lead training program up to 12 months after the expiration of the license or accreditation without penalty of reapplying as a new applicant. The Board may identify additional areas for amendment or elimination of regulations in accordance with the Governor’s Regulatory Reform initiative while drafting the proposed text.

A public hearing will be held following the publication of the proposed stage of this regulatory action and notice of the hearing will be posted on the Virginia Regulatory Town Hall website (<http://www.townhall.virginia.gov>) and on the Commonwealth Calendar website (<http://www.virginia.gov/cmsportal3/cgi-bin/calendar.cgi>). Both oral and written comments may be submitted at that time.

The agency is using the participatory approach in the development of the proposal. Pursuant to the Public Participation Guidelines, 18VAC15-11-10 *et seq.*, a panel will not be used.

### Family impact
