These regulations were developed in 1986 and do not reflect all changes in the Code of Virginia that have occurred since that time. Also, they do not reflect the current administration of the statutory provisions and regulations by the Virginia Waste Management Board. This action makes those changes needed for the regulations to conform to Virginia statutes. The major changes are the replacement of references to the Hazardous Waste Facility Siting Council and its Executive Director with references to the Virginia Waste Management Board and the Director of the Department of Environmental Quality. Legal citations are replaced with those that are currently correct. Other changes include providing current addresses and the current manner of conducting business tasks under the regulations. This action also incorporates a delegation by board to the Director of the Department of Environmental Quality to administer the regulations to the extent that such delegations are not proscribed by the statute. This delegation is a confirmation of pre-existing statutory authority under §10.1-1405.

Statement of Final Agency Action

On May 12, 2005, the Virginia Waste Management Board approved this action, Immediate Final Rule 2005, and adopted the rule as final regulations of the board, Schedule of Fees for Hazardous Waste Facility Site Certification, 9 VAC 20-20.
