The Alcoholic Beverage Control Board intends to amend 3 VAC 5-50-170, which deals with licensed caterers. The contemplated amendment would reduce the advance notice required of events to be catered under a caterer's license from two days to 24 hours.

The Board contemplates amending 3 VAC 5-50-170 by reducing the advance notice which must be given the Board by any licensed caterer of events to be catered under his license from two calendar days to 24 hours.

In 3 VAC 5-50-170, subsection C4, the language "two calendar days" shall be changed to "twenty-four hours" for advanced notice to the Board of events to be catered. The phrase "for

the following month" at the end of the first sentence of the subsection will be deleted. A second sentence will be added to the subsection providing that notice of events to be catered on days on which the Board's offices are not open shall be given by close of the last business day prior to the event.

The Board will initiate a review and re-evaluation to determine if the regulation should be continued, amended, or terminated on May 1, 2003. The goals of this regulation are: To prescribe reasonable minimum qualifications for holders of retail licenses; and To promote the public health, safety, and welfare by reasonably regulating retail alcoholic beverage sales so as to prevent sales to those under the legal age or intoxicated, and to discourage over-consumption.
