In conformity with amendments to the Code Of Virginia made by Chapter 465 of the 2001 Acts of the Assembly, the Board of Medicine has amended sections 10, 130, 140 and 150 of its regulations for physician assistants to eliminate current requirements for a formulary of approved drugs and conform its requirements to provisions of law on expanded prescriptive authority.

On June 7, 2001, the Virginia Board of Medicine adopted amendments to 18 VAC 85-50-10 et seq. (Regulations Governing the Practice of Physician Assistants).

The Assistant Attorney General has certified that amendments to 18 VAC 85-50-10 et seq. are “necessary to conform to changes in Virginia statutory law or the appropriation act where no agency discretion is involved”. Therefore, § 9-6.14:4. (C) (4) is applicable and the amendments are exempt from Article 2 of the Administrative Process Act.

Family Impact Statement
