Following the receipt and consideration of a petition for rulemaking, the Board voted to grant the petition and initiate rulemaking. The petition requested that the Board accept evidence of retired licenses of psychology in other jurisdictions. The Board felt that it should initiate additional changes to licensure by endorsement requirements as well to reduce the burden on applicants.

Regulations of the Board of Psychology are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Virginia Code § 54.1-2400(6) specifically states that the general powers and duties of health regulatory boards shall be "[t]o promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) that are reasonable and necessary to administer effectively the regulatory system."

The Board intends to amend the requirements for licensure by endorsement to increase the number of individuals that may be licensed through this pathway.

The Board will add the ability to provide evidence of a retired license from another jurisdiction that was in good standing prior to retirement in support of an application for licensure by endorsement. In addition, the Board will consider limiting 18VAC125-20-42(4) to requiring verification of a license in one other jurisdiction (rather than verification of all an applicant may hold) and simplification of the requirements in 18VAC125-20-42(6).
