This regulatory action changes the existing language of the regulations (9VAC15-70) to incorporate the change of the name of the position of "Secretary of Natural Resources" to "Secretary of Natural and Historic Resources". § 2.2-4006 A 4 a of the Administrative Process Act allows the Board to adopt a regulatory amendment that is necessary to conform to changes in Virginia statutory law. This regulatory action is required to conform the existing regulation to changes in the Code.

HB1836 passed during the 2021 Reconvened Special Session I of the Virginia General Assembly. This bill changed the name of the position of “Secretary of Natural Resources” to “Secretary of Natural and Historic Resources”. The Governor signed the bill into law on March 30, 2021 (HB1855 – Virginia Acts of Assembly Chapter 401).
