requires the Department to promulgate regulations that create a certification program for certified natural gas automobile mechanics and technicians.

The number of CNG vehicles has continued to increase steadily since their inception in the late 1970's. The General Assembly has determined that this program is necessary to insure that the public be protected against incompetent, unqualified, unscrupulous, or unfit persons engaging in the activities regulated by this newly created chapter.

A public hearing will be held following the publication of the proposed stage of this regulatory action.

The agency is using the participatory approach in the development of the proposal. Pursuant to the Public Participation Guidelines, 18 VAC 50-11-10 *et seq.*, a panel will not be used.
