The regulations are mandated by § 46.2-1157.1 and are necessary to carry out the regulatory functions of the Department. No need for changes was identified during the review process.

Small business impact

In determining economic impact on small business the agency determined that (1) the statutory authority both authorizes and necessitates the continued need for the

regulation; (2) that no complaints or comments were received concerning the regulation from the public; 3) the regulation is not complex and provides a basic framework for administering the program; 4) the regulation does not overlap, duplicate, or conflict with federal or state law or regulation; and 5) that technological, economic, or other changes in the area affected by the regulation have not impacted the need or form of the regulation. The regulation intended to protect the citizens of the Commonwealth is consistent with the stated objectives of applicable law and has little or no economic impact on small businesses. The requirement to have these signals is statutory in nature so the regulations do not impose any additional duty on small business. The regulation shall therefore be retained in its current form.
