The State Water Control Board adopted this regulation under the authority of §62.1-44.15 (10) of the Code of Virginia.

## **Alternatives**

This regulation prohibits owners of a sewerage system or sewage treatment plant serving more than 400 people from discharging untreated or inadequately treated sewage, from connecting to an existing sewer, or from extending the sewer unless authorized by the board. Section 62.1-44.19 of the Code of Virginia requires Board approval of sewerage systems and sewage treatment works.

One alternative considered was the repeal of this regulation. This regulation is being repealed since it is no longer necessary. The Board's Sewage Collection and Treatment (SCAT) Regulations, 9VAC25-790-10 et seq., became effective on February 12, 2004. Under the SCAT Regulations, no person shall construct, expand, or modify a sewerage system or sewage treatment works except in compliance with a

Certificate to Construct from the Department and in accordance with the detailed standards contained within the regulations. As a result, the more generalized requirements of 9VAC25-80-10 et seq. (General Regulations Under State Water Control Law - Requirement No. 1) are no longer needed and can be repealed.
