Section 10.1-1436 A of the Code of Virginia authorizes the Virginia Waste Management Board to "promulgate criteria for approval of hazardous waste facility sites." This regulation was promulgated by the Virginia Waste Management Board to establish siting criteria for hazardous waste facility sites.

There are no federal statutory or regulatory requirements upon which this regulation is based.

Alternatives to Regulation

The Department considered repealing the regulation. This alternative was rejected. Repealing this regulation would not be protective of human health and the environment since it would remove the protective criteria evaluated for the siting of a hazardous waste facility. The Department also considered revising the regulation. This alternative was also rejected since the regulation, as currently written complies, with the minimum requirements of the legal mandates and does not place unreasonable hardships on the regulated community without justifiable benefits to human health and protection of the environment.

The regulation continues to be needed to establish siting criteria for hazardous waste facilities.

No public comments were received during the public comment period.

This regulation establishes siting criteria for hazardous waste facility sites. It is clearly written and is consistent with the requirements of statute and other related regulations.

This regulation does not overlap, duplicate, or conflict with any state law or other state regulation. This regulation is part of a set of four related regulations mandated by Virginia statutes that establish a procedure for siting of hazardous waste management facilities including certification of the site, investigation of the site, resolution of issues between the applicant and the host community, and funding the process.

A periodic review was last conducted on this regulation in 2016 and the regulation remains current.

The Department has determined that the regulatory requirements currently minimize the economic impact of these regulations on small businesses while meeting the requirements of state law.
