[§ 45.1-161.106](#) of the Code of Virginia (Code) authorizes the Chief of DMME's Division of Mines (Chief), after consultation with the Virginia Coal Mine Safety Board (CMSB), to promulgate regulations necessary to ensure safe and healthy working conditions in underground coal mines in the Commonwealth. Also, [§ 45.1-161.114](#) of the Code specifically directs the Chief to promulgate regulations requiring automated temporary roof support systems for the installation of roof bolts.
