A motion was made by Ms. Berney and seconded by Mr. Pollard to accept the Consent Order wherein Rosewell Memorial Garden admits to a violation of 18 VAC 47-20-200.C of the Board's 2005 regulations (2 violations) and agrees to a monetary penalty of \$200.00 for each violation contained in Count 1 and agrees to pay \$150.00 in Board costs for a total of \$550.00. The motion passed unanimously. Members voting "Yes" were Bell, Berney, Doherty, King, Kirsch, and Pollard.

File Number 2007-01275 Rosewell Memorial Garden, Inc.

In the matter of File Number 2007-01276 Heritage Family Cemetery File Number 2007-01276 Inc., the Board reviewed the record which consisted of the Consent Heritage Family Order. A motion was made by Mr. Kirsch and seconded by Mr. Doherty to accept the Consent Order wherein Heritage Family Cemetery Inc. admits to a violation of 18 VAC 47-20-190.1 of the Board's 2000 Regulations and agrees to a monetary penalty of \$150.00 for the violation contained in Count 1, and agrees to pay \$150.00 in Board costs for a total of \$300.00. The motion passed unanimously. Members voting "Yes" were Bell, Berney, Doherty, King, Kirsch, and Pollard.
