Ms. Sweet reported that the practical portion of the exam will be administered on December 3, 2004 at J. Sargent Reynolds Community College and the theory portion will be administered November 17, 2004 at both the Wytheville and Richmond location.

Ms. Sweet presented the Opticians Apprenticeship Curriculum Task Force report. The Task Force submitted to the Board an Optician Apprenticeship Related Instruction Curriculum and recommended 324 hours of related instruction to complete the apprenticeship program. Ms. Sweet ended the report by fielding questions from the board members.

The Board upon a motion by Mr. Shell and seconded by Ms. Taylor Instruction voted to adopt the Optician Apprenticeship Related Instruction Curriculum and the recommended 324 hours of related instruction to complete the apprenticeship program. Ms. Sweet stated the next step was to meet with the Community Colleges and the Department of Labor and Industry regarding the curriculum.

Ms. Dugger distributed a flowchart of the current organizational Flowchart processes and functions involved in the administration of the Optician Apprenticeship Program.

Mr. Bright reported on his attendance at the National Committee of National State Opticianry Regulatory Boards (NCSORB) conference held on October 23, 2004, and the Opticians Association of America 2004 Opticians Conference October 21-24, 2004, in Lexington, Kentucky.

Committee of State **Opticianry** Regulatory Boards Conference

Mr. Bright reported there are 19 states with optician licensure and 10 representatives were present at the meeting. Mr. Bright stated that the primary topic was apprenticeship training and standardization of apprenticeship training on a national level. Attendees noted that most states do not recognize out-of-state apprenticeship programs.

Mr. Bright reported that discussion of a regional/national practical exam was also a topic of great interest and that there is meeting scheduled to discuss standardization of the practical exam the 2<sup>nd</sup> week in March 2005 in New York.
