Lue Walton, ARCAP, LC, and SV LC, et al., the Board reviewed the record which consisted of the Final Investigative Report, Case Analysis and supplemental Final Investigative Report. Dr. Vivian A. Anderson, complainant, and Jeffrey Marks, attorney for the respondents, were present and addressed the Board. A motion was made by Mr. Crouse and seconded by Ms. Bennett to find no reasonable cause that the respondents discriminated against the complainant by imposing discriminatory terms and conditions based on race. The motion passed unanimously. Members voting "Yes" were: Bennett, Crouse, Lynch, Melton, Murphy, Northup, Reisinger, Schaberg and Spanberger.

Horizon House Condominium Unit Owners Association, David Clark, Betty Plummer, FirstService Residential DC Metro, LLC, Omar Davis, Don Bachenberg and Phil Pool, the Board reviewed the record which consisted of the Final Investigative Report and Case Analysis, supplemental Final Investigative Report and revised Case Analysis. Bobbie Fisher, complainant, and Kevin Kernan, attorney for the respondents, were present and addressed the Board. A motion was made by Mr. Murphy and seconded by Mr. Northup to find no reasonable cause that the respondents discriminated against the

complainant by offering discriminatory terms and conditions or intimidated, harassed or coerced the complainant based on sex and race. The motion passed unanimously. Members voting "Yes" were: Crouse, Lynch, Melton, Murphy, Northup, Reisinger, Schaberg and Spanberger. Bennett abstained from voting in this matter.

In the matter of FHB File Number 2018-00063, Jennifer Hernandez v. Northern Virginia Family Services, Inc., the Board reviewed the record which consisted of the Final Investigative Report and Case Analysis and supplemental Final Investigative Report. Jennifer Hernandez, complainant, was present and addressed the Board. A motion was made by Mr. Northup and seconded by Mr. Schaberg to find no reasonable cause that the respondents discriminated against the complainant by refusing to rent or otherwise make housing unavailable based on color or The motion passed unanimously. Members disability. voting "Yes" were: Bennett, Crouse, Lynch, Melton, Murphy, Northup, Reisinger and Spanberger. Bennett abstained from voting in this matter.

FHB File Number 2018-00063, Jennifer Hernandez v. Northern Virginia Family Services, Inc.

In the matter of FHB File Number 2016-02856, Tiffany and Shane Northedge v. KADK, LLC and Kathy MacMillan, the Board reviewed the record which consisted of the Final Investigative Report and Case Analysis. A motion was made by Mr. Crouse and seconded by Mr. Murphy to find no reasonable cause KADK, LLC and Kathy MacMillan, respondents, discriminated against the complainant by refusing to rent or by making a discriminatory statement based on familial status. The motion passed unanimously. Members voting "Yes" were: Bennett, Crouse, Lynch, Melton, Murphy, Northup, Reisinger and Spanberger. Schaberg abstained from voting in this matter.

FHB File Number 2016-02856, Tiffany and Shane Northedge v. KADK, LLC and Kathy MacMillan

A motion was made by Mr. Lynch and seconded by Ms. Spanberger to find reasonable cause that the KADK, LLC and Kathy MacMillan, respondents, discriminated against the complainant by refusing to rent and by making a discriminatory statement based on disability. The motion passed unanimously. Members voting "Yes" were: Bennett, Crouse, Lynch, Melton, Murphy, Northup, Reisinger and Spanberger. Schaberg abstained from voting in this matter.

A motion was made by Ms. Bennett and seconded by Mr. Northup to find reasonable cause KADK, LLC, and Kathy MacMillan, respondents, discriminated against the complainant by refusing to rent and by making a discriminatory statement based on gender. The motion passed unanimously. Members voting "Yes" were: Bennett, Crouse, Lynch, Melton, Murphy, Northup, Reisinger and Spanberger. Schaberg abstained from voting in this matter.

In the matter of FHB File Number 2016-02682, Karen E. Jacobs (formerly Karen Garnett) v. Fore Property Company and Fore Courthouse Seniors, LP, a motion was made by Mr. Reisinger and seconded by Mr. Murphy to approve the terms of the conciliation agreement as agreed to by the parties.
