Mr. Thomas reported he attended the Fall ASBOG meeting. He stated that it was a very productive meeting. Erick Weiland of Arizona was elected President. There were 20 member states at the meeting.

Ms. Nosbisch informed board members that they will receive an email later this month from the Virginia Conflict of Interest and Ethics Advisory Council regarding their yearly statement of economic interests (SEI). Ms. Nosbisch stated that completion of the SEI form is a requirement for board members and that the online form must be completed by all board members between January 2018 and February 1, 2018.

Statement of Economic Interest

Mr. Thomas stated he believes it is beneficial to the profession to have required annual continuing education. Ms. Nosbisch noted that geologists are certified so continuing education is not required. Mr. Thomas stated that seven out of 32 states require continuing education; they are all licensing states. The Board discussed continuing education. Although continuing education is beneficial, it is not a requirement. For this to become a requirement, Virginia Code would need to be changed, and the trend is to deregulate rather than increase regulation.
