Ms. Laney reported that the Committee granted Dr. Dail's petition for modification of the Consent Order dated March 7, 2014.

The license of Dr. Dail to practice dentistry is indefinitely suspended; with the suspension stayed and shall remain stayed contingent upon his continued compliance with all of the requirements of the Virginia Health Practitioners' Monitoring Program ("HPMP") for the duration specified by the HPMP.

Based on the findings in the March 7, 2014 Consent Order, Dr. Dail is assessed a monetary penalty of \$1,000.00; within 12 months from the date of entry of the Order, Dr. Dail shall successfully complete a 30 hour hands-on surgical continuing education course covering implant training, and a 7 hour continuing education course in recordkeeping and risk management. Dr. Dail is prohibited from performing and/or completing any surgical procedures or implants as set forth in the March 7, 2014 Consent Order.

Within 90 days from the date of entry of the Order, Dr. Dail shall pay the administrative costs assessed in the March 7, 2014 Consent Order in the amount of \$5,000.00.
