Additionally, Ms. Ridout moved that Ms. Palmatier, Ms. Lee, and Ms. Jones attend the closed meeting because their presence in the closed meeting is deemed necessary and their presence will aid the Committee in its deliberations. Ms. Ridout moved that the Committee certify that it heard, Reconvene:

> discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was

convened. The motion was seconded and passed.

DECISION: The sanctions reported by Ms. Jones were that Dr. Popli is

reprimanded; shall pay a \$5,000.00 monetary penalty; and within

successfully complete a 4 credit hour continuing education course in the subject of OSHA and infection control, a 3 credit hour continuing education course in the subject of recordkeeping, and a 7 credit hour continuing education course in the subject of proper dental accounting, coding and billing practices.

Ms. Ridout moved to adopt the decision of the Committee. The motion was seconded and passed.

Nantadla Abinader, D.D.S. Case No.: 160789

The Committee received information from Ms. Palmatier regarding a request by Dr. Abinader for modification of his Board Order entered May 24, 2016, that requires him to successfully complete a 7 credit hour continuing education course in dental accounting, coding, and billing practices; and a 7 credit hour continuing education course in recordkeeping and risk management.
