Chetana S. Saxena, D.M.D. Dr. Saxena appeared with counsel, Douglas M. Coleman, to discuss the allegations set forth in the Amended Notice of the

Board dated December 20, 2016. Michael Pollowitz, D.D.S., appeared as an expert witness on behalf of Dr. Saxena. The Committee received additional evidence and statements from Dr. Saxena, Dr. Pollowitz, and Mr. Coleman and discussed the

allegations with them.

The motion was seconded and passed.

**DECISION:** 

Case No.: 157493

The sanctions reported by Ms. Jones were that Dr. Saxena shall be reprimanded and pay a \$10,000.00 monetary penalty. Within 12 months from the date of entry of the Order, Dr. Saxena shall successfully complete a 7 credit hour continuing education course in proper dental accounting, coding and billing for herself and her staff; a 7 credit hour hands-on course on the principles of endodontics and treatment; a 4 credit hour continuing education course in diagnosis and treatment planning protocol; and a 3 credit hour continuing education course in the subject of recordkeeping. Dr. Saxena will also be subject to one unannounced records audit within six months from the completion of the continuing education course in proper dental accounting, coding and billing.

Dr. Bryant moved to adopt the decision of the Committee. The motion was seconded and passed.
