The sanctions reported by Ms. Palmatier were that Dr. Crockett shall pay a monetary penalty of \$3,000.00; and that within 6 months from the date of entry of the Order, he shall successfully complete a 4 credit hour continuing education course in the subject of OSHA guidelines; 7 credit hours in the subject of principles of dental record keeping and risk management; and 7 credit hours in the subject of proper dental accounting, coding and billing practices for all employees of his dental practice.

It was further Ordered that Dr. Crockett shall be the subject of an unannounced office inspection, which shall include a review of office premises and a review of five complete patient records.

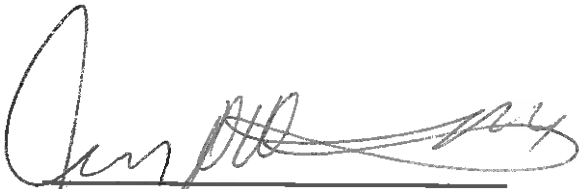
Ms. Ridout moved to adopt the decision of the Committee. The motion was seconded and passed.
