Case No.: 168671** Dr. McCrady appeared with counsel, Donna Foster, to discuss the allegations set forth in a Notice of the Board dated May 16, 2017. Christopher Reho, court reporter, was present to provide a verbatim transcript of the proceeding. Mr. Reho was not present on behalf of the Board or Dr. McCrady. Dr. James G. Schroeder appeared on behalf of Dr. McCrady.
- Ms. Foster objected to the presence of the court reporter because she did not know who requested the court reporter since he was not there on either Mr. McCrady's behalf or the Board's behalf. Ms. Foster also noted her exception to the Board's rulings on her previous motions regarding the evidence submitted by the Board.
- The Committee received statements from Dr. McCrady, Dr. Schroeder, and Ms. Foster and discussed the allegations with them.
- Closed Meeting:** Dr. Bonwell moved that the Committee convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Carl McCrady. Additionally, Dr. Bonwell moved that Ms. Palmatier, Ms. Lee, and Ms. Jones attend the closed meeting because their presence in the closed meeting is deemed necessary and their presence will aid the Committee in its deliberations.

Dr. Bonwell moved that the Committee certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. DECISION:

Case No.: 168671

The sanctions reported by Ms. Jones were that Dr. McCrady shall be reprimanded, and pay a \$5,000.00 monetary penalty. Within 6 months from the date of entry of the Order, Dr. McCrady shall successfully complete a 3 credit hour continuing education course in the subject of dental recordkeeping; 4 credit hour continuing education course in the subject of endodontic diagnosis and treatment; a 4 credit hour continuing education course in the subject of principles of fixed prosthodontics; and a 4 credit hour continuing education course in the subject of fundamentals of caries detection.


Dr. Bryant moved to adopt the decision of the Committee. The motion was seconded and passed.
