Within 6 months from the date of entry of the Order, Dr. Abu-Ghannam shall successfully complete the following continuing education courses: 3 hours in the subject of dental billing and coding; 3 hours in the subject of sedation recordkeeping; 7 hours in the subject of recordkeeping and risk management; and 8 hours in the subject of diagnosis and treatment planning.

Within 45 days from the date of entry of the Order, Dr. Abu-Ghannam shall submit a name change to the Board.

Mr. Martinez de Andino moved to adopt the decision of the Committee. The motion was seconded and passed.
