Case No.: 229953** Mr. Sheta appeared without counsel to discuss the allegations set forth in a Notice of the Board dated February 2, 2024. The Committee received statements from Mr. Sheta and discussed the allegations with him.

Closed Meeting: Mr. Martinez moved that the Committee convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Amr Sheta. Additionally, Mr. Martinez moved that Ms. Weaver and Ms. Lee attend the closed meeting because their presence in the closed meeting was deemed necessary and their presence would aid the Committee in its deliberations. The motion was seconded and passed.

Reconvene: Mr. Martinez moved that the Committee certify that it heard, discussed, or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded and passed.

Ms. Weaver reported that the Committee granted Mr. Sheta's application for reinstatement of his dental license to practice dentistry in the Commonwealth of Virginia contingent on the following conditions: Completion of a refresher course of at least 8 hours in general dentistry from a CODA-accredited institution; successful completion of a 4-hour continuing education course in the subject of principles of endodontics; successful completion of a 3-hour continuing education course in the subject of principles of prosthodontics; and proof of a current hands-on CPR certification from a Board-approved sponsor.

The Committee further ordered that upon reinstatement of Mr. Sheta's dental license, he shall be prohibited from prescribing Schedules II-IV controlled substances for a period of at least 2 years from the date of reinstatement of his license.


Mr. Martinez moved to adopt the decision of the Committee. The motion was seconded and passed.
