- CALL TO ORDER:** A Special Conference Committee of the Board was called to order at 9:18 a.m.

- DISCUSSION:** Dr. Akers-White appeared before the Committee in person in accordance with a Notice of the Board dated July 1, 2021. Dr. Akers-White was not represented by counsel.
- The Committee fully discussed the allegations in the Notice with Dr. Akers-White.
- CLOSED SESSION:** Upon a motion by Dr. Barner, and duly seconded by Dr. Miller, the Committee voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Dr. Akers-White. Additionally, she moved that Dr. Harp and Ms. Wood attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations.
- RECONVENE:** Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session and announced its decision.

DECISION: Upon a motion by Dr. Miller, and duly seconded by Dr. Barner, the Committee made certain findings of fact and conclusions of law and voted to issue Dr. Akers-White a reprimand, impose a monetary penalty and subject her license to terms and conditions.

VOTE: The vote was unanimous.

ADJOURNMENT: The Committee adjourned at 11:21 a.m.

As provided by law this decision shall become a Final Order thirty (30) days after service of such Order on Dr. Akers-White, unless a written request to the Board for a formal hearing on the allegations made against her is received from Dr. Akers-White, within such time. If service of the Order is made by mail three (3) additional days shall be added to that period. Upon such timely request for a formal hearing, the decision of the Special Conference Committee shall be vacated.
