
- CALL TO ORDER:** A Special Conference Committee of the Board was called to order at 9:04 a.m.

ADJOURNMENT: The Committee adjourned at 10:25 a.m.



- CALL TO ORDER:** A Special Conference Committee of the Board was called to order at 10:36 a.m.

- PRELIMINARY MATTER:** The Chair noted that the time was 10:37 a.m. and Dr. MacCannon was noticed to appear before the Committee at 9:00 a.m. and was not present.
- Ms. Hinton advised that the Notice had been sent to Dr. MacCannon's address of record with the Board by overnight and First class mail.
- RULING:** Based on the information provided by Ms. Hinton, the Chair determined that proper notice had been provided to Dr. MacCannon, therefore, the informal conference would proceed in her absence.
- DISCUSSION:** Dr. MacCannon did not appear before the Committee in accordance with the Board's Notice of Informal Conference dated April 6, 2022, nor was she represented at the conference by legal counsel.
- The Committee fully considered the evidence before it and received information from Ms. Hinton regarding the allegations in the Notice.

Upon a motion by Dr. Barner, and duly seconded by Dr. Pradhan, the Committee voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Dr. MacCannon. Additionally, she moved that Ms. Deschnes and Ms. Hines attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations.

RECONVENE:

Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session and announced its decision.

DECISION:

Upon a motion by Dr. Barner, and duly seconded by Dr. Pradhan, the Committee voted to refer this matter to a formal hearing since the suspension or revocation of Dr. MacCannon's license may be justified which is not within the authority of the Committee pursuant to §54.1-2400 (10) of the Code of Virginia.
