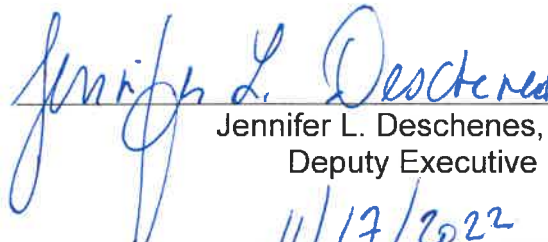

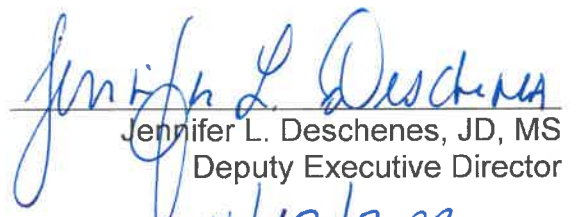
**VOTE:**
