The meeting was called to order by Mr. Jones. With nine members of the Board of Nursing participating, a quorum was established.

Erin Weaver, Assistant Attorney General, presented evidence that the continue practice of Nursing by **Tanya Ann McInturff, RN (0001-196402)** may present a substantial danger to the health and safety of the public.

**CLOSED MEETING:** Ms. Swineford moved that the Board of Nursing convene a closed meeting pursuant to §2.2-3711(A)(27) of the Code of Virginia at 4:17 P.M., for the purpose of deliberation to reach a decision in the matter of **Tanya Ann McInturff** . Additionally, Ms. Swineford moved that Ms. Douglas, Ms. Morris, Ms. Bargdill, Ms. Vu, Ms. Goode, Ms. Renick and Ms. Mitchell attend the closed meeting because their presence in the closed meeting is deemed necessary and their presence will aid the Board in its deliberations. The motion was seconded by Mr. Monson and carried unanimously.

**RECONVENTION:** The Board reconvened in open session at 4:32 P.M.

Ms. Swineford moved that the Board of Nursing certify that it heard, discussed, or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded by Dr. Dorsey and carried unanimously.

Dr. Gleason moved to summarily suspend the license of **Tanya Ann McInturff** to practice professional nursing in the Commonwealth of Virginia pending a formal administrative hearing and to offer a consent order for indefinite suspension of her license in lieu of a formal hearing for a period of not less than two years. The motion was seconded by Ms. Buchwald and carried unanimously.
