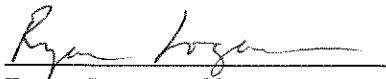
Reconvene:

Upon a motion by Mr. Ratliff and duly seconded Mr. Logan, the Committee unanimously voted to refer the matter to the full Board for a formal hearing.

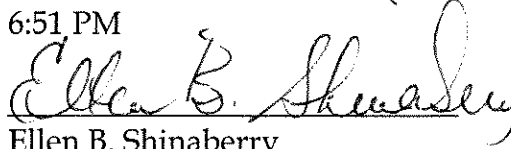
