**Minutes:** February 16, 2017 minutes approved.

#### **Current Issues:**

### **Riverfront Development Plan Update:**

- T. Potterfield Bridge Updates
  - o Tricia will start forwarding JRP visitor counts to the committee as received from Nathan Burrell.
  - Jane Meyers reported that in a meeting with City Park and Recreation officials, she suggested that they
    provide a phone line with updates concerning trail conditions and if they were dry enough to ride/run

#### Downriver Updates:

- o It was reported that demolition of the Sugar Pad has begun.
- Greg Velzy has not contacted City Planning re: a Water Taxi System along the Canal from 14<sup>th</sup> Street Dock to Chapel but thought he should first contact Alex Dahm – Venture Richmond who currently run Canal Boats in the City Dock portion and then will contact City Planning.

### • Next Phase - Missing Link

- No report on Grant Application for trail feasibility study.
- Ralph White has met with engineers from Norfolk and they said the cantilevered walkway was not
  possible, but perhaps a MRE (mechanical, stabilized earth) structure could be doable. Greg and Ralph
  Hambrick will try to meet with the contact (Mike) tomorrow.

**EnRichmond:** Leighton Powell has not been able to meet with John Sydnor concerning the Passages contracts or Vauxhall Island, but noted that in another meeting with the City Parks and Recreation Advisory Committee, Debra Morton stated that they are currently reviewing all vendor contracts with all Parks, and Leighton will be certain to advocate for the JRP receiving the moneys from JRP and Passages contracts. Leighton said she would talk with John Sydnor about the contracts and Vauxhall Island status.

**Falls Committee Meeting with Levar Stoney:** No progress. Leighton stated that she is working to become an advisor to Stoney on such matters.

### **Capital Region Land Conservancy:**

- Parker and Jane met with John Sydnor and the Land Committee Capitol Region Land Conservancy. She said
  that EnRichmond is concerned about putting land Vauxhall Island under the JRP easement because of
  distrust of DPU. They will go ahead and add to the easement when the amendment on Restatement of
  Easement is completed. It will supersede the past easement to not cite a DPU easement for this. EnRichmond
  feels that the City will not accept an encumbered piece of property. It should be noted that the City would lose
  the VLCF funding (by September and thus would not be able to purchase from EnRichmond), so they must act
  quickly.
- Capital Region Land Conservancy has had two successful events where they reached out to landowners along
  the James River about establishing a conservation easement on private lands. About 20 people attended and
  event at Westover Plantation and others at Bon Air Library.
- Conservation Easement Inspections of the James River Park have been conducted. They are monitoring the James River report concerning the impact of impervious surfaces with regard to the easement updates concerned about impact of Manchester projects. Other than that they see little change.

**James River Park Economic Development Study:** Nathan has gone to a conference in London – Richmond Upon Thames and to study their trail system. The Economic Impact Study is in the number crunching state with all surveys completed. This needs to come out ASAP as budgets are in process.

**Master Plan Funding and Preparation:** Nathan has received proposals from VHB, Hargreaves and one that is a hybrid between VHB/Hargreaves. They will be distributed after his return from the UK. Price range from \$170,000.00 to \$250,000.00.

**GRTC Bus Routes:** No letter has been written to GRTC, but we did receive an email from Nathan that the current plan to go to City Hall had no River Stops.

### **New Business:**

**FOLAR** – Friends of the Lower Appomattox River has released a masterplan for a world class trail system along the Lower Appomattox River (with paved paths – maybe for accessibility)

**Chesterfield County** has asked for and received money to implement a plan for a network of trails on the Brown & Williamson addition along the James River (An earlier 265 acre land gift to the County with almost one mile of river frontage).

#### Reports:

#### James River Park:

As stated Nathan is in Richmond Upon Thames as part of a delegation celebrating the 400th anniversary of the death of Pocahontas.

**JRA:** Working to illuminate the fact that the waste ponds at Dutch Gap Dominion Pant are leaking into the lagoon.
